A spacious storage room, which could be used flexibly to suit the future owners' needs, completes the ground floor. A family room and study are located on the lower ground floor, making the house well-suited to both entertaining and everyday living. Three bedrooms are arranged across the upper levels of this home, all of which have the benefits of en suite bathrooms and integrated wardrobes.

French doors from one of the bedrooms open directly onto a private terrace, creating a seamless extension of the living space and a rare opportunity for outdoor dining and relaxation.
