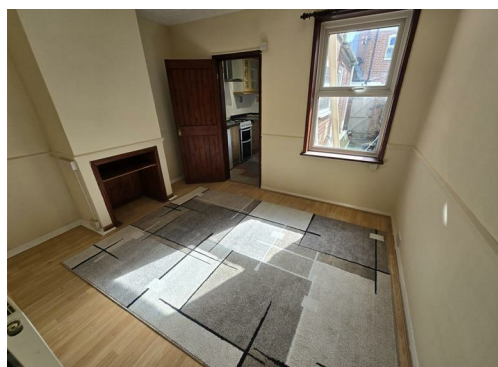

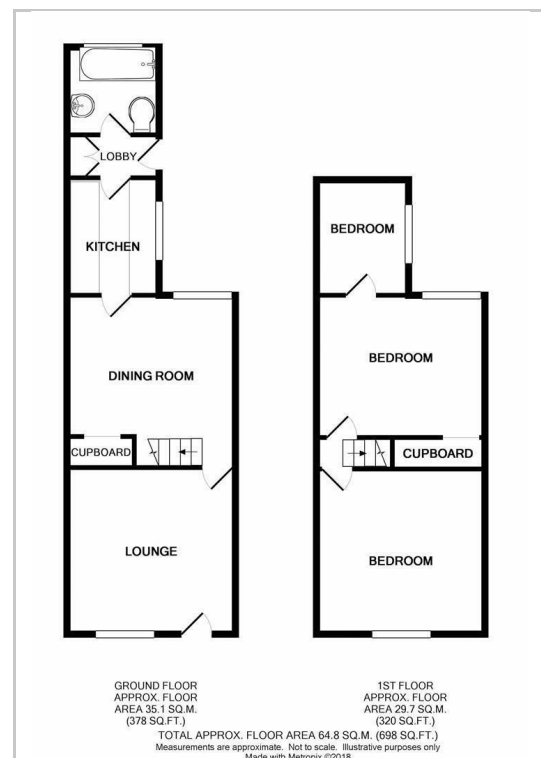

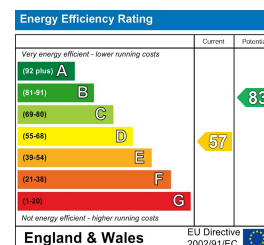
Area Map
