An exceptional split-level maisonette arranged over the raised and lower ground floors of a handsome stucco-fronted building on Onslow Gardens, SW7. Extending to over 2,280 sq ft, the property combines generous proportions, versatile accommodation, and direct access to the communal gardens. The raised ground floor offers superb entertaining space, with a reception room opening to the gardens, alongside a dining room, kitchen, and guest cloakroom. The lower level features three double bedroom, each with en suites, together with a utility/kitchen area and access to two paved terraces. The principal bedroom enjoys its own outdoor space, enhancing the appeal. Currently arranged as two interconnecting flats, the property provides flexibility to be enjoyed as a larger family home or separated into two independent units.
