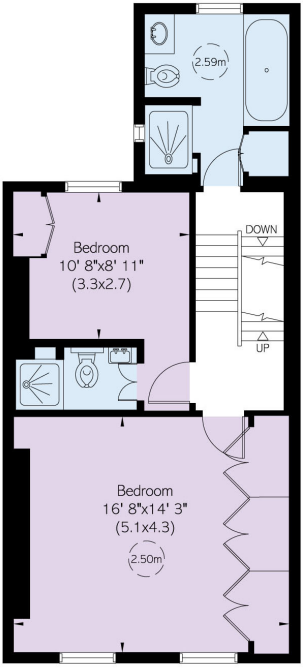
Lower Ground Floor



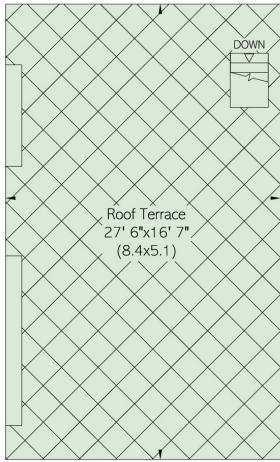
Raised Ground Floor
