Driveway providing off road parking and access to front door.

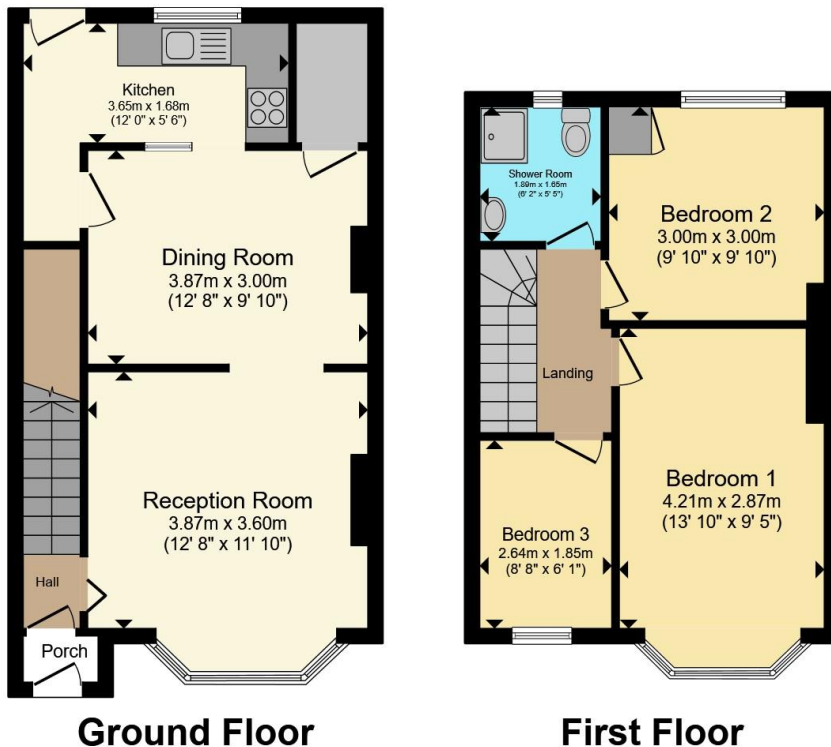
Rear Garden
