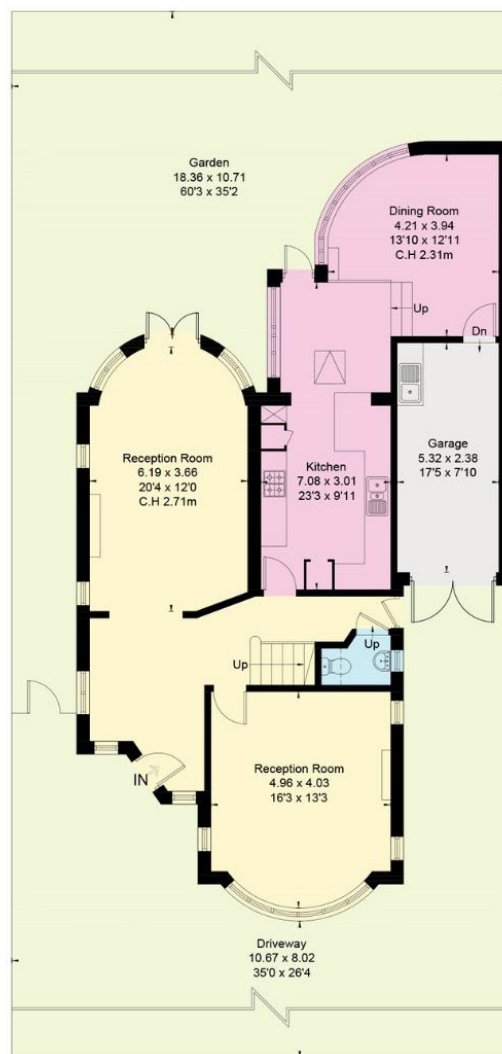

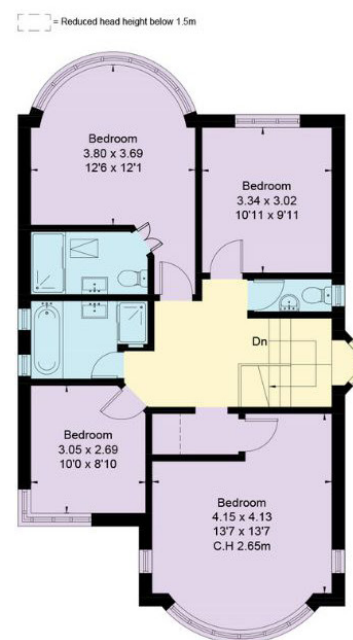








Ground Floor
