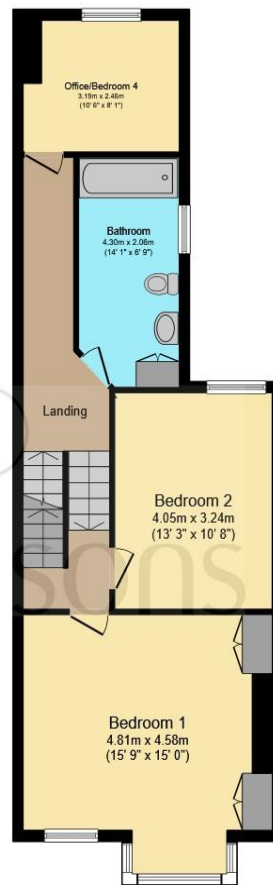




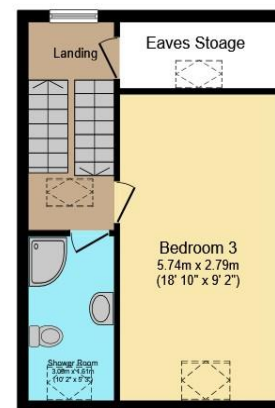
Lower Ground Floor
