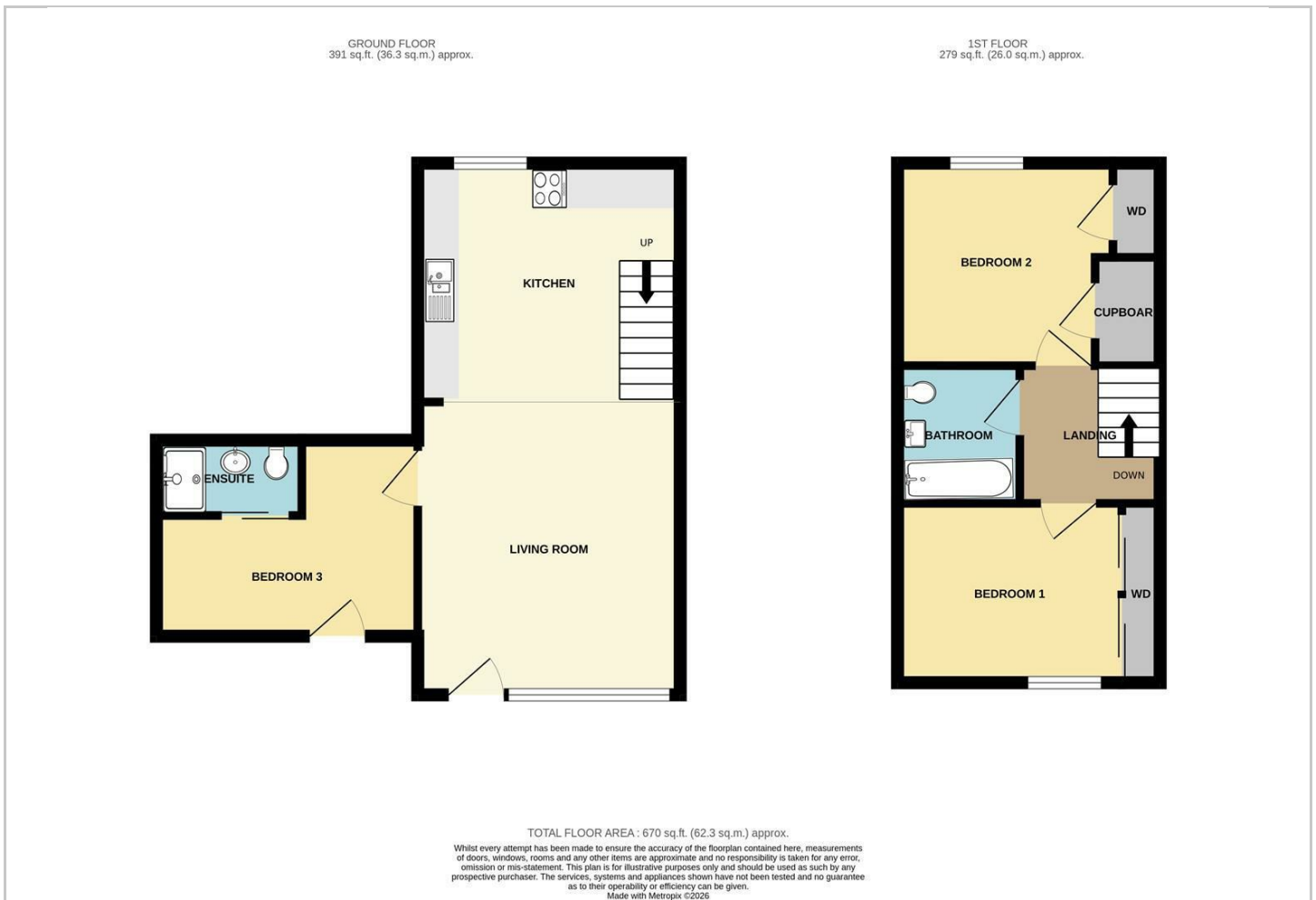
Hybrid Map
