Quietly set back from the centre of Market Deeping, the home enjoys an idyllic backdrop of open field views with wonderfully landscaped, southerly facing gardens leading directly down to the gentle River Welland, creating a serene



environment that feels worlds away from everyday life. Scenic walking routes and riverside paths sit right on the doorstep, perfect for those who enjoy the outdoors and a relaxed pace of living. Despite its peaceful setting, Eastgate remains conveniently positioned, with the welcoming local pub, popular coffee shop, and the community hall all within walking distance, offering fitness classes, clubs and social activities - ideal for meeting neighbours and easing into village life, especially for those new to the area.

Stepping inside, the property opens into a welcoming hallway before flowing into an impressive 39ft open plan living/dining/kitchen space, beautifully designed with a feature log effect fire, stylish fitted kitchen with central island, lantern window and rear seating area enjoying views over the garden.

The ground floor also offers a cloakroom, while upstairs the principal bedroom enjoys a Juliet balcony framing the stunning river and countryside scenery, along with built in wardrobes and an en suite. Two further bedrooms and a modern family bathroom complete the first floor.

Outside, a block paved driveway provides parking for up to four vehicles, while the thoughtfully landscaped rear garden includes a covered glazed loggia, lawned areas, a timber shed, and steps leading to a lower terrace with a charming summerhouse and covered patio positioned perfectly to take in the breathtaking riverside views.

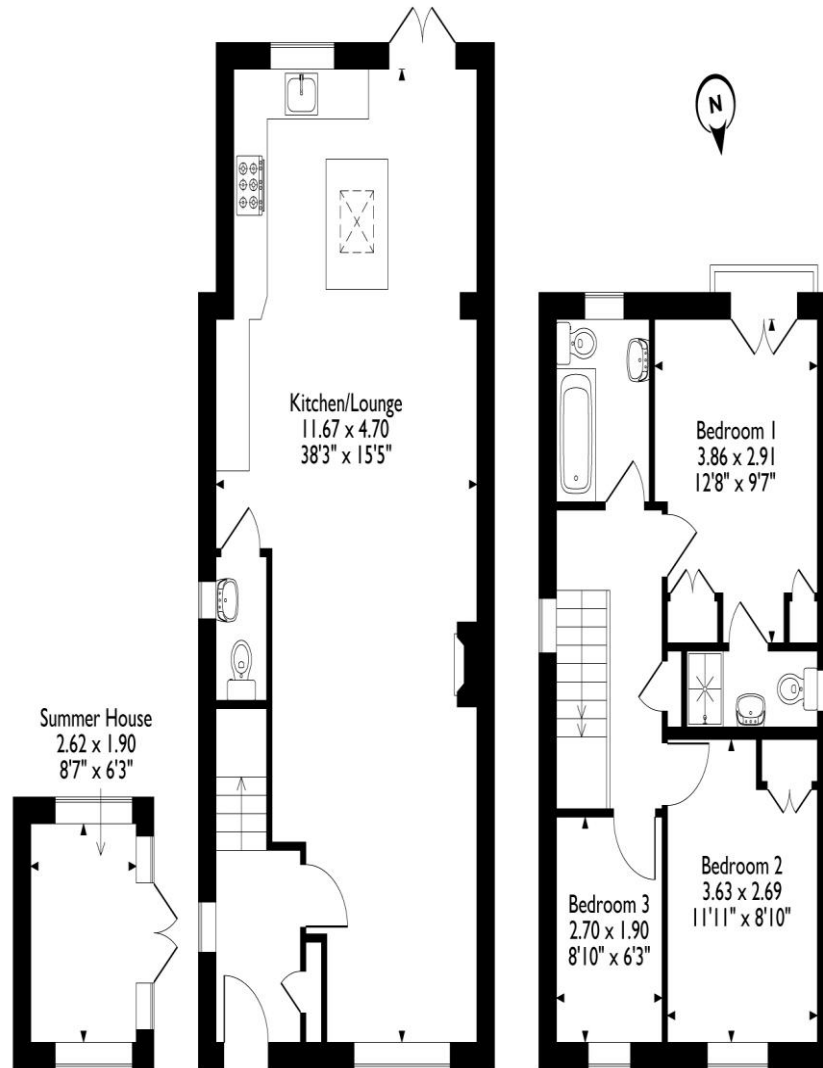
