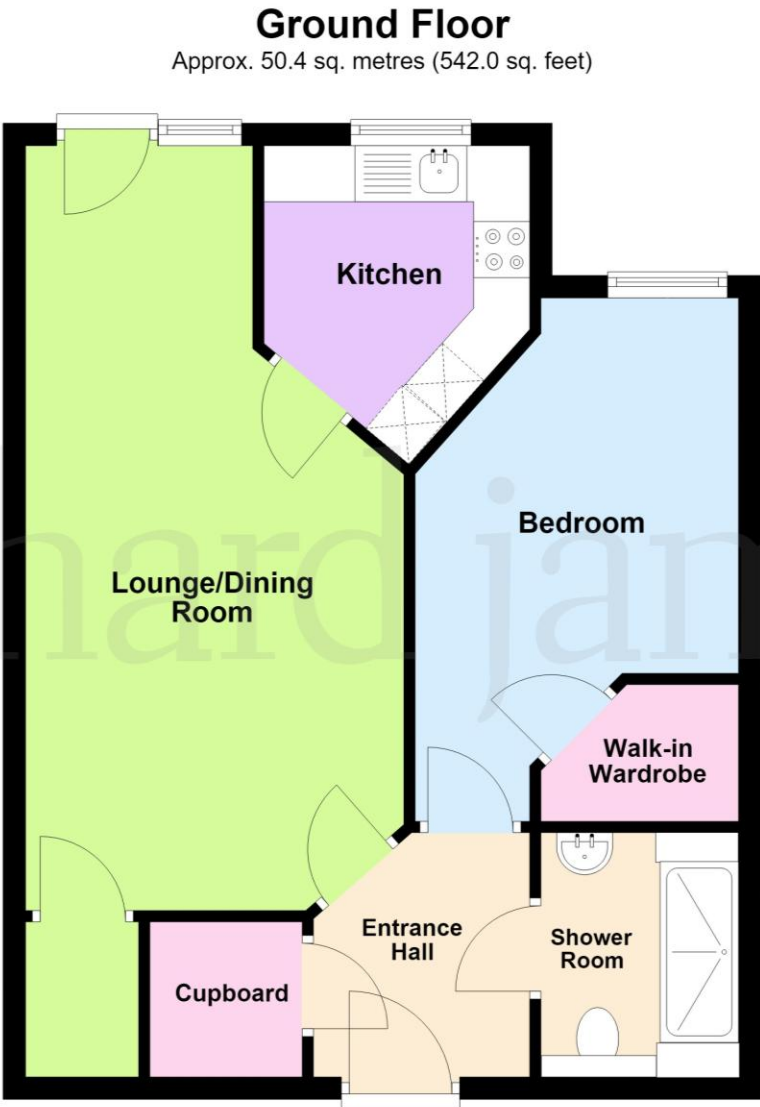

Residents have access to all communal areas including gardens and residents lounge which hosts regular activities and entertainment. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, bedroom, shower room and allocated parking for one vehicle.
