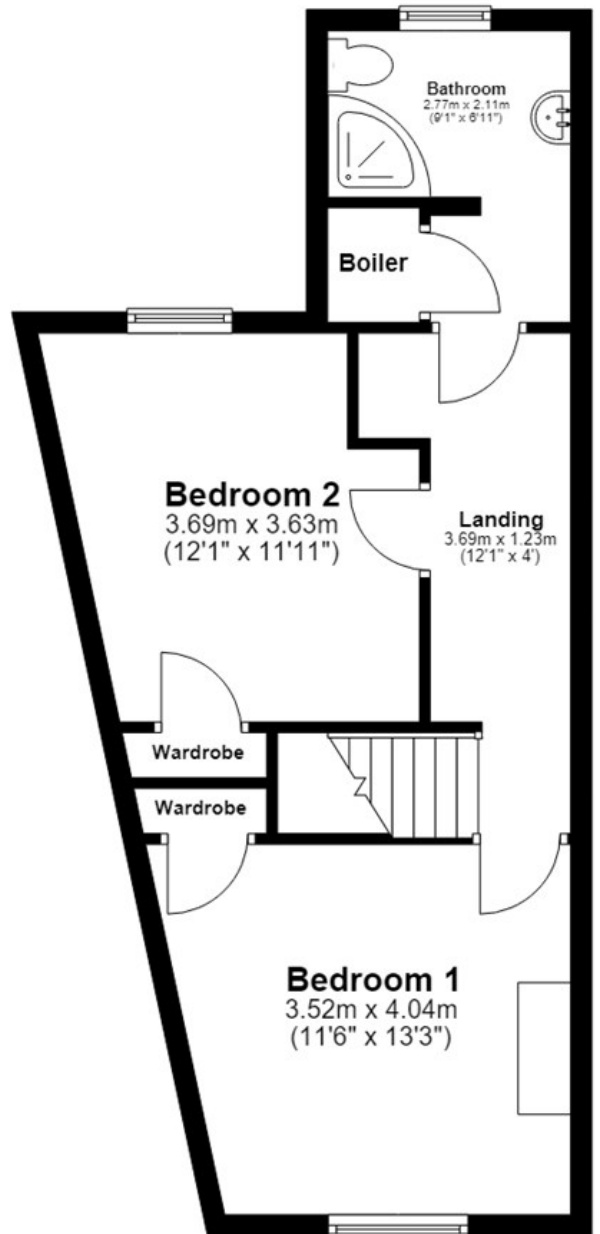
Ground Floor
