Door to front and central heating radiator.

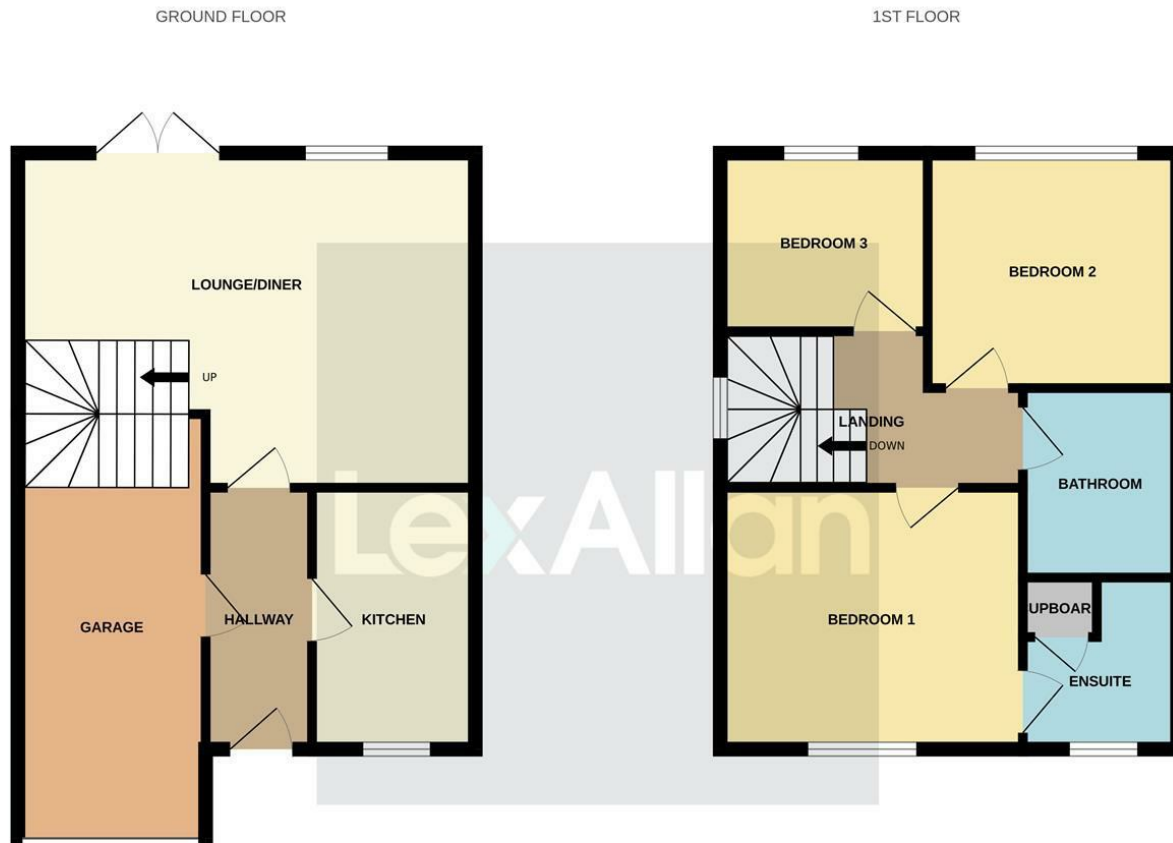
