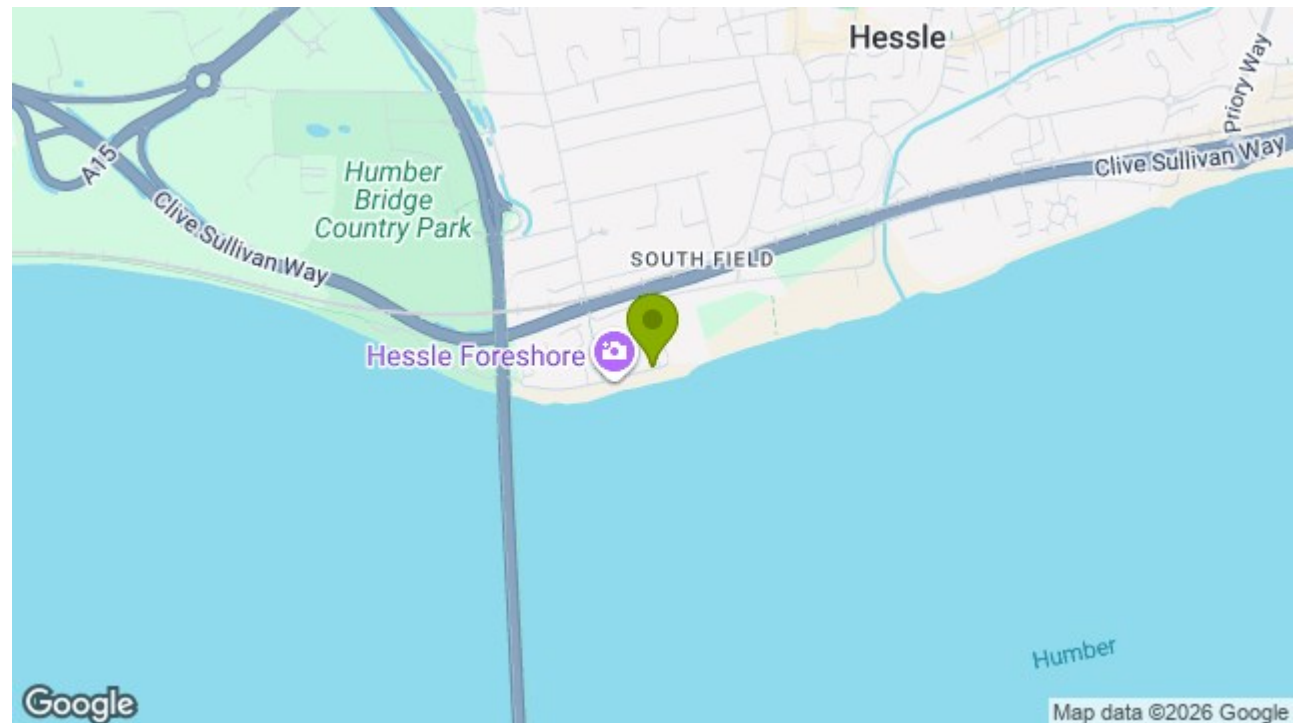

HESSLE

The Town of Hessle is well served for local amenities with first class shopping facilities available within the Town Centre, public transportation & local primary and secondary schools. GROUND FLOOR;

ENTRANCE HALL

A welcoming entrance hall providing access to the accommodation with stairs and storage cupboard off.

LIVING / DINING ROOM

A generous reception space with ample room for living and dining furniture. With bay window to the front elevation and French doors to the rear.

KITCHEN

With cream gloss wall and base units, laminated work surfaces and splashback. Integrated appliances include an Electric Hob, Electric Oven and an extractor. Further benefitting from a window to the rear elevation and plumbing for an automatic washing machine.

BEDROOM 1

A bedroom of double proportions with fitted sliding wardrobes and a bay window to the front elevation.

BEDROOM 2

A generous bedroom with fitted sliding wardrobes, two windows to the rear elevation and a Velux window.

BATHROOM

Fabulous bathroom with a four piece suite comprising of a shower enclosure, bath and a vanity unit housing both a WC and a wash hand basin. Further benefitting from partially tiled walls, a heated towel rail, window to the side elevation and a Velux window.

A private rear courtyard with raised decking area, timber fencing and gate.

An allocated space within the rear car park.

SERVICES - Mains water, electricity, gas and drainage are connected to the property.

DOUBLE GLAZING - The property has the benefit of replacement PVC double glazed frames.
