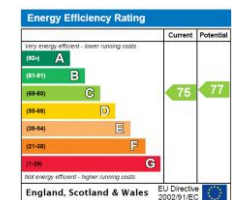
Positioned within an attractive period building and benefiting from lift access, the property combines character, convenience and an exceptional sense of outlook.

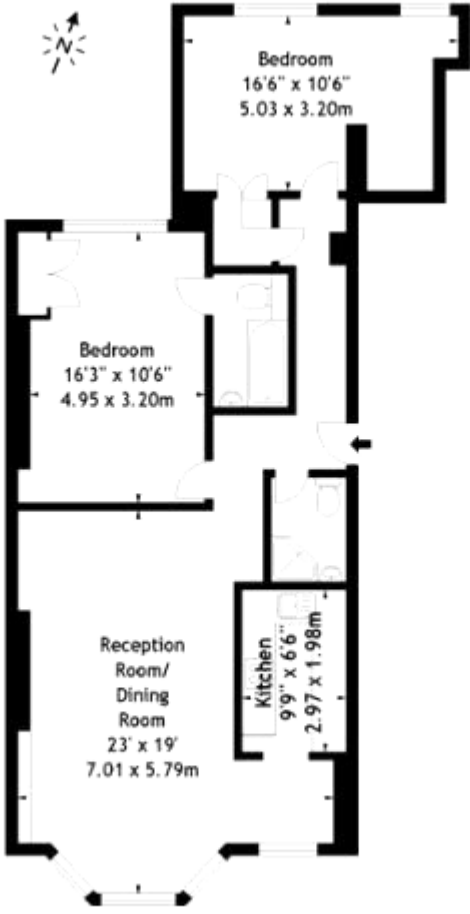
