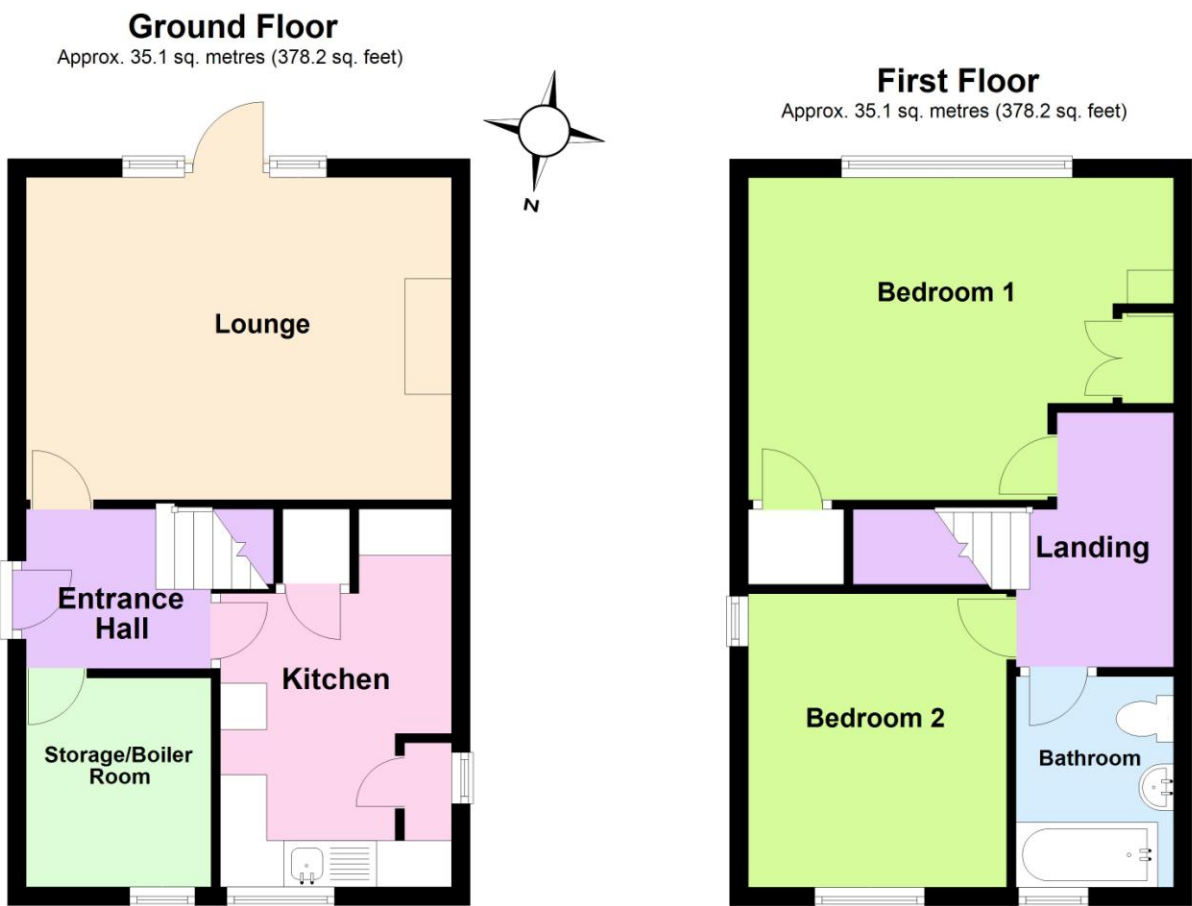

Offered with no upward chain is this two double bedroomed end terraced property which features a generous south facing rear garden with benefits to include uPVC double glazing, gas radiator central heating, modern kitchen, modern bathroom and offers a 60ft rear garden. The property does require cosmetic updating throughout. The accommodation briefly comprises entrance hall, lounge, kitchen, store/boiler room, two bedrooms, bathroom, gardens to front and rear.
