Hallway

Door to side, central heating radiator, tile floor and stairs off.

Downstairs WC

WC, wash hand basin with mixer tap, central heating radiator, tile floor and extractor fan.

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, oven, space and plumbing for washing machine, tile floor and splash backs.

Double glazed windows and french doors to rear garden, cupboard off and central heating radiator.

Double glazed window to front and doors off.

8' 6" x 11' 9" (2.6 x 3.6)

Double glazed window to rear and central heating radiator.

Double glazed window to rear and central heating radiator.

Bathroom

Heated towel rail, WC, bath with mixer tap and electric shower over, wash hand basin with mixer tap and storage below, tile floor and splash backs, double glazed window to front and extractor fan.

Main garage door accessed to the rear of the property.
