

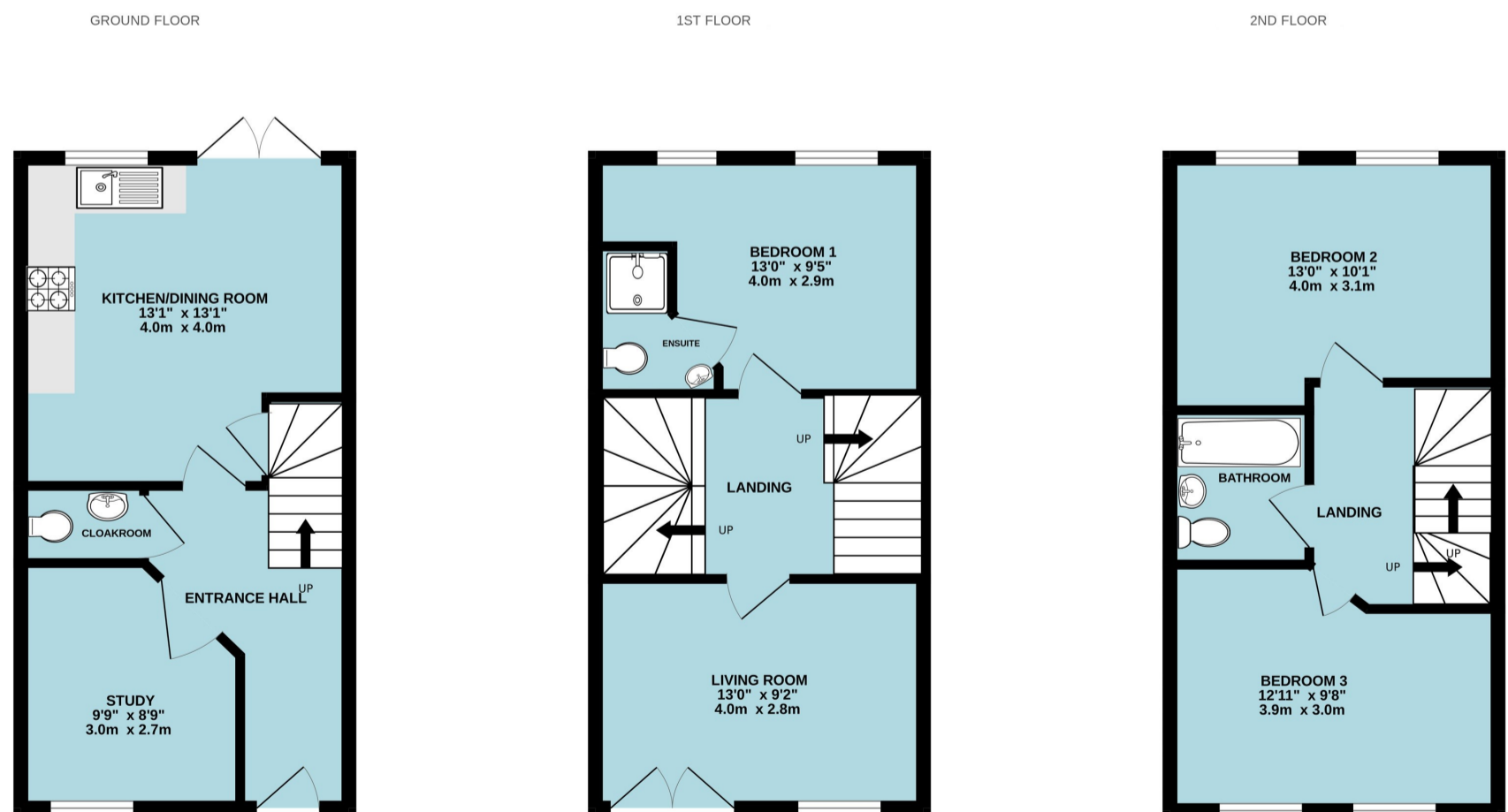

Description

Vita Avenue is a beautifully presented three bedroom town house situated on the popular Kings Down development with off-road parking for two vehicles.

THE PROPERTY:

The accommodation comprises an entrance hall, cloakroom, useful study and kitchen/dining room which opens to the rear garden.

To the first floor is a modern living room with a Juliet balcony and a bedroom with an en-suite.

To the second floor are a further two bedrooms complemented by a family bathroom.

Outside – As previously stated there are two off-road parking spaces allocated to this property. The garden to the rear is a blank canvas and could be made into a lovely family garden.

The property benefits from gas fired central heating throughout, double glazing and integrated appliances within the kitchen.

A viewing of the dwelling comes highly recommended to appreciate its style and location within the development.

LOCATION:

Situated on the newly built Kings Down development on the edge of the market town of Bridgwater. Access to the M5 motorway is easily accessible via junction 23. Bridgwater town centre is a level walk away and offers a full range of amenities including retail, educational and leisure facilities. The Kings Down development offers a newly built primary school and a regular bus service to the town centre. There are regular bus services from Bridgwater Bus Station to Taunton, Weston-super-Mare and Burnham-on-Sea plus a daily coach service to London Hammersmith. Main line links are available via Bridgwater railway station.
