A paddock and former football field, offering a level area and pasture. Currently approved for equestrian usage with planning permission for a stable block with two loose boxes and tack room with mains electricity and mains water on site. Set in an accessible elevated location with far reaching views making this a good small equestrian proposition with some superb local riding through green lanes.

Viewing is highly recommended to appreciate the location.

## Situation

Cornworthy is a well-kept and attractive village, surrounded by beautiful countryside. There is a very active Village Hall and a thriving local Inn, renowned for its friendliness. Cornworthy is approached by country lanes yet lies within easy reach of Dartmouth (7 miles), perfect for sailing enthusiasts. The historic town of Totnes is about 5 miles and offers a great range of independent shops, main-line station, recreational and educational provision. Many footpaths and good walking to both Bow Creek and the River Dart with Blackness Marine a short drive away, an excellent facility for boating enthusiasts. And the delightful village of Dittisham is 2.4 miles with its own sailing club and facilities.

## Description

Having for many years been the local football playing field the land has now been granted change of use for equestrian usage with stabling for two and tack room. Please refer to floorplans for the siting of the stable block. The land benefits from some far reaching views enjoyed from the property over the rolling South Hams countryside. The level area may suit a variety of other usage (subject to any necessary planning consents), possibilities for an outdoor schooling area.

## Planning Permission

There is an access track with hard standing frontage to the front of the stable building, identified tree planting bank against the former level playing field/football pitch, with identified soak away on the plans. Potential purchasers are asked to view the whole planning documents on the South Hams website portal under the Planning Reference: 3504/25/FUL. Please make note of any pre-commencement conditions and any conditions attached to the planning.

## Status

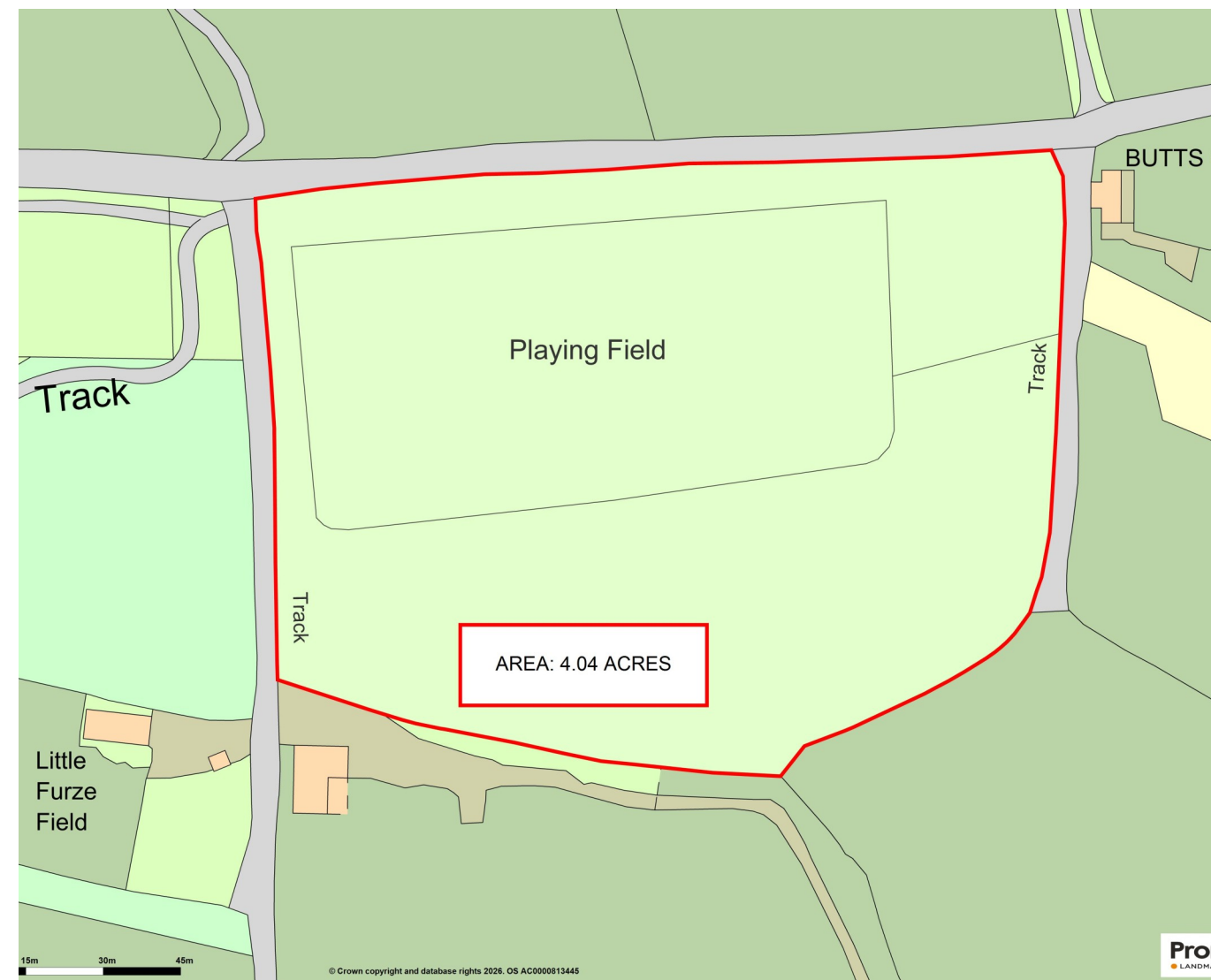

From Totnes take the A381 Kingsbridge Road. After about 1 mile take a left turn to Ashprington, Tuckenhay and Cornworthy. Follow the signs into Tuckenhay passing the Watermans Arms and the Malsters Arms. Pass through the village, following signs for Cornworthy and crossing the stone bridge. Proceed for about 1 ½ miles and at the 'T' junction at Abbey Cross turn right to East Cornworthy, continue on Water Lane, passing through Furzehill Cross, continue onward signed East Cornworthy/ Dittisham for 432 meters and the gate can be found on your right.
