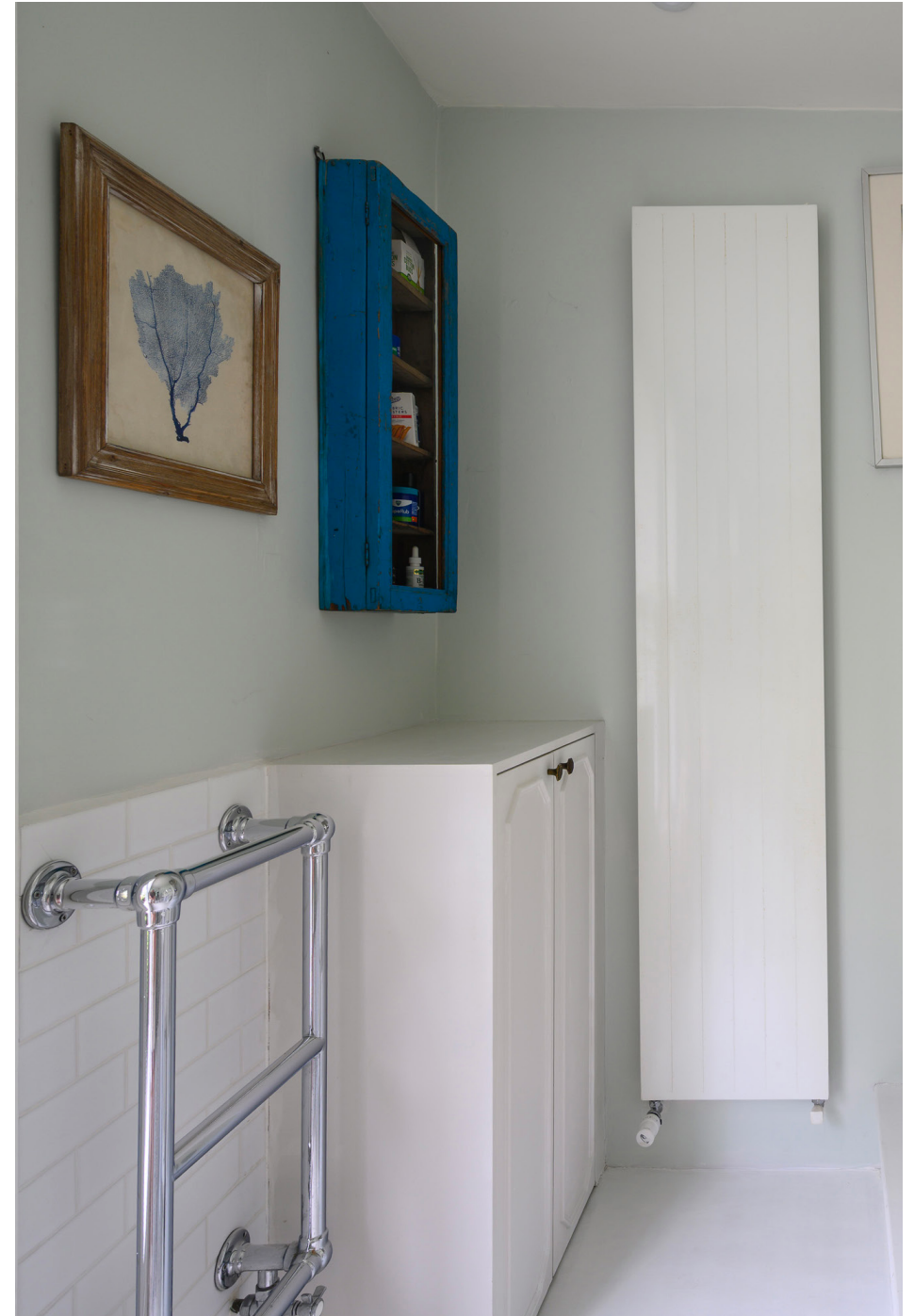




MOMENTS FROM PORTOBELLO

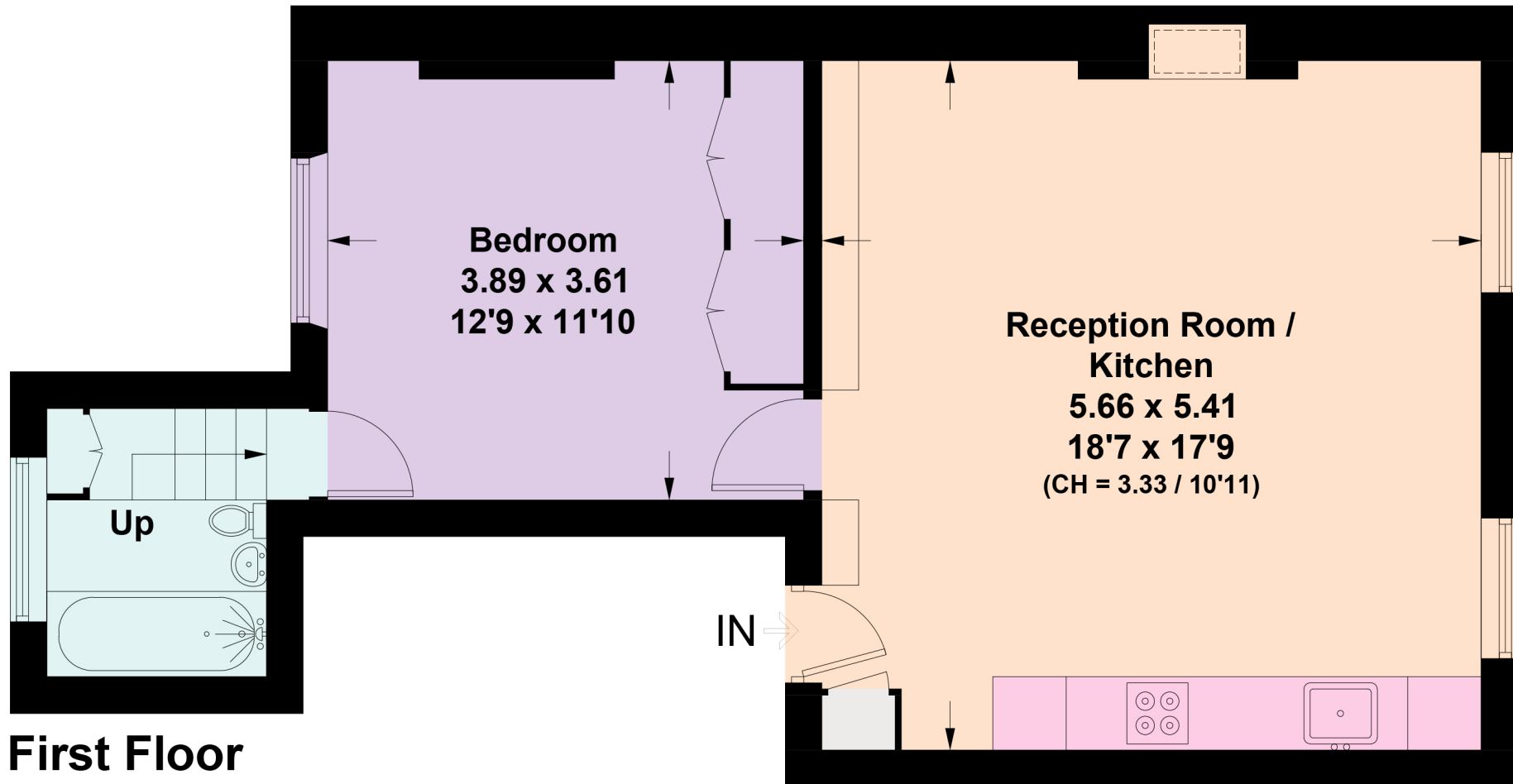
