Internal accommodation, over three floors, consists of an entrance hallway, spacious lounge and kitchen breakfast room to the ground floor. The first floor holds an impressive main bedroom and a shower room whilst the second floor holds two further bedrooms. Externally the property holds a west facing patio with a generous garden as well as two brick storage sheds. UPVC double glazing in present throughout as well as LPG gas central heating. EPC rating G (prior to boiler replacement, and North Yorkshire Council rating C.

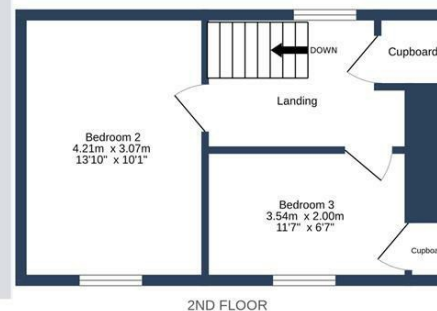
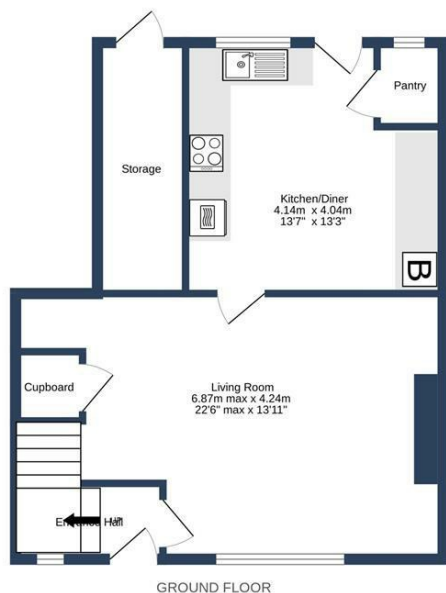
