Location

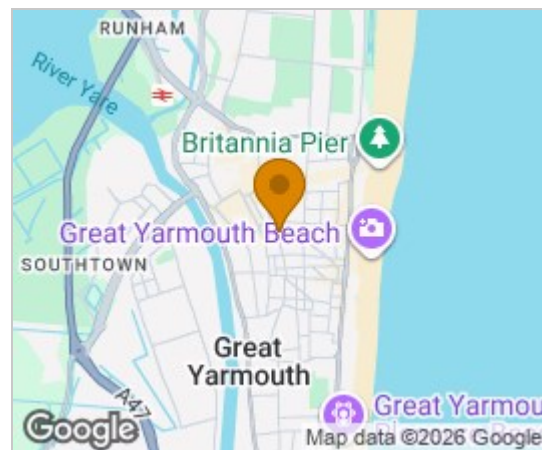

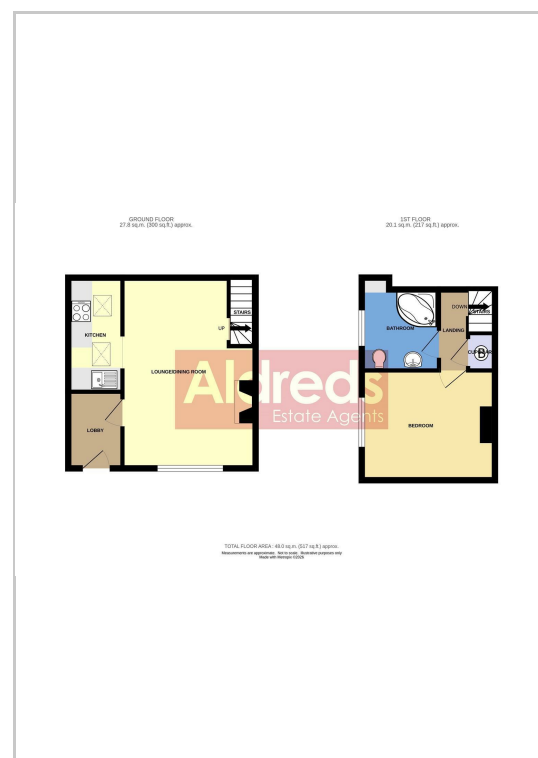

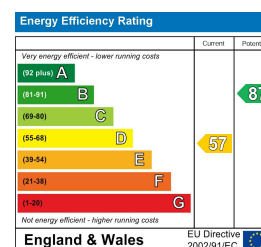
Area Map
