The accommodation briefly comprises entrance hall, cloakroom, lounge, dining room, kitchen, three bedrooms, shower room, separate WC, rear garden, garage, workshop and driveway.

Entrance Hall

Stairs rising to first floor landing, radiator, under stairs storage cupboard, airing cupboard housing wall mounted gas boiler serving domestic central heating and hot water systems, doors to:

Cloakroom

Refitted to comprise low flush W.C., pedestal wash hand basin, tiled splash backs, window to side aspect, radiator.

Dining Room

12' 0" x 11' 4" max (3.66m x 3.45m)

Window to front aspect, radiator, feature fireplace.

Lounge

17' 3" max x 10' 11" max (5.26m x 3.33m)

Door and window to rear aspect, window to side aspect, feature fireplace, radiator.

Comprising stainless steel one and a half bowl single drainer sink unit with cupboard under, a range of eye level and base units providing work surfaces, built-in gas hob with extractor hood, double oven, plumbing for washing machine, space for slimline dishwasher, space for under counter fridge, window to rear aspect, radiator, tiled splash backs.

Comprising low flush W.C., window to side aspect.

Outside

Front - Block paved driveway providing off road parking, enclosed by low brick walling.

Garage - Accessed via double wooden doors.

Rear - Patio area, mostly lawn, outside tap, greenhouse, enclosed by wooden fencing with gated side pedestrian access.

Workshop - 9' 7" x 8' 1" window to rear aspect, door and window to side aspect, power and light connected.
