Location

Located on Garden Village, the property is well placed for host of amenities along Holderness Road. The Woodford Leisure centre and East Park are nearby.

Entrance Hall

Main single glazed entrance door provides access into the property. Stairs lead off to the first floor accommodation.

Windows to the front and rear elevations. Two fire surrounds both with gas fires.

Breakfast Kitchen

Fitted with a range of base and wall units, work surfaces with single drainer sink unit. Appliances of oven and hob. Space for washer, dryer and fridge/freezer. Two windows to the side elevation. Side entrance door.

Access to roof void which houses the gas fired water heater.

Suite of bath, wash hand basin and WC. Window to the front elevation. Part panelled walls.

Outside

There are garden areas to the front and rear. A pedestrian footpath leads to the front door. The larger rear garden has a lawn and patio area. At the far end of the garden there is a useful timber shed. The garage currently on site requires replacement. Access is from the ten foot at the rear.
