

THE PROPERTY

The ground floor features a dual-aspect reception room with a fireplace, and wood-burning stove. Double doors open to a bright orangery with glass ceiling and panoramic windows. There's also a formal dining room, a study ideal for home working, and a stylish kitchen with wooden units, granite worktops, central island, Aga, and integrated Neff oven. A ground-floor double bedroom with en suite provides perfect guest accommodation. Upstairs, a spacious landing leads to six bedrooms. The principal suite includes a dressing area and en suite shower room, while the second bedroom also benefits from an en suite and dressing space. Three further doubles and a single share the family bathroom.









