First Floor: Landing, two double bedrooms and house bathroom.

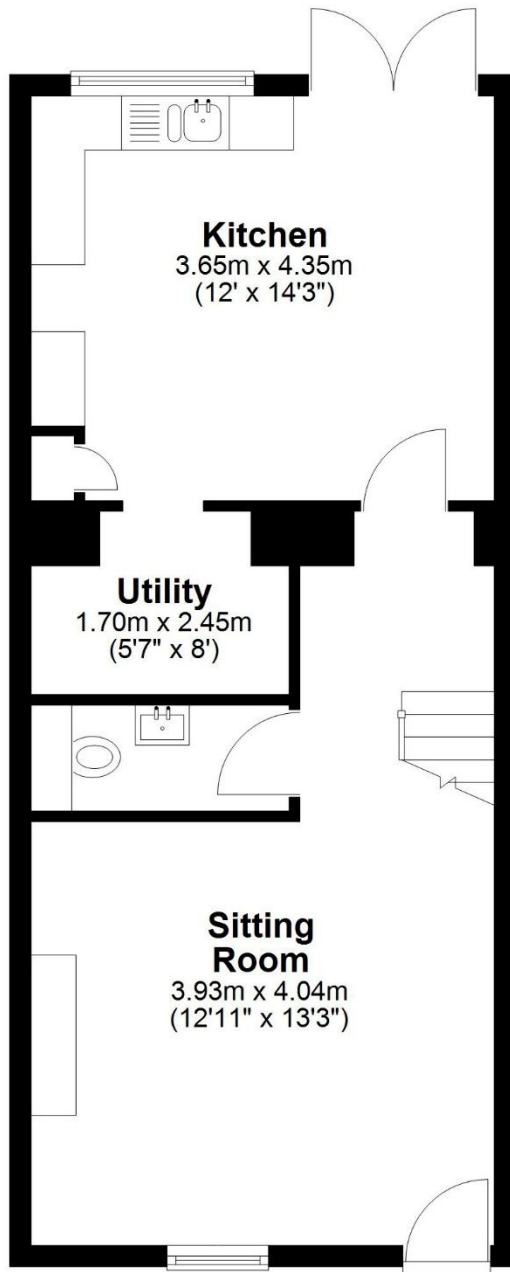
Externally: Utility with underfloor heating. Small rear yard, timber outbuilding with power laid on, plus a delightful yet enclosed lawned rear garden with beds.

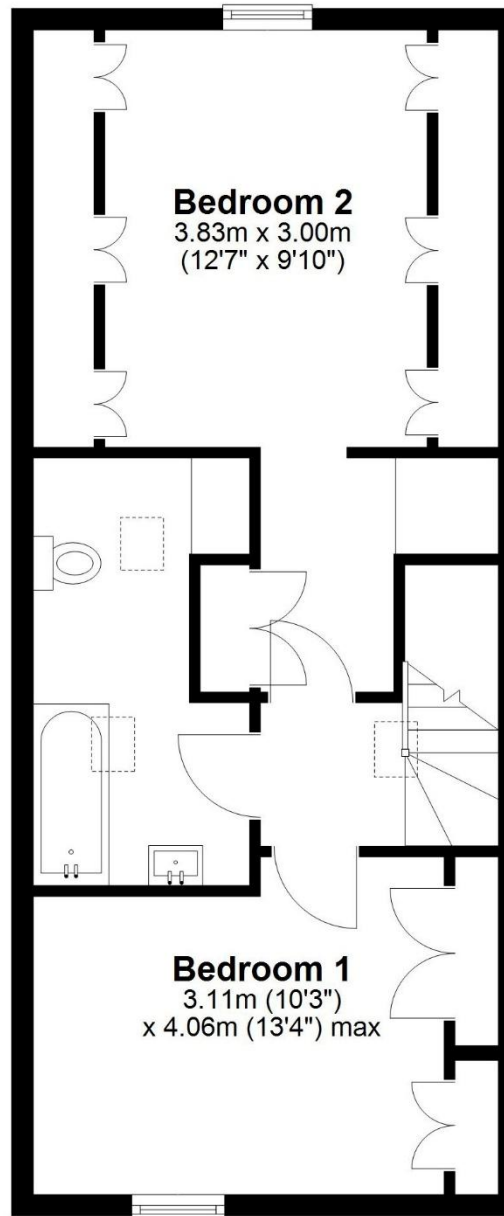
## Ground Floor

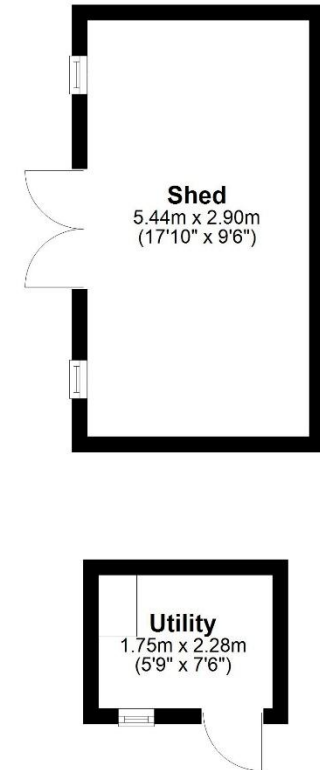
## First Floor
