In brief the property consists of; a porch, an entrance hall which allows access down into the useful chamber cellar, a good-sized front facing lounge with bay window, a family room, a white three-piece shower room, and a sizeable kitchen/diner with views and access out into the rear private garden.

Stairs leading to the first-floor landing reveal three good sized bedrooms, the principle benefitting from a bay window. A white three-piece bathroom suite completes this floor.

To the second floor there is a further large double bedroom completing this fantastic property.

The property benefits from gas fired central heating, high ceilings, period features, stripped and varnished floor boards, and a rear enclosed garden. The property also offers a unique Sonos in ceiling sound system which is controlled via an app.
