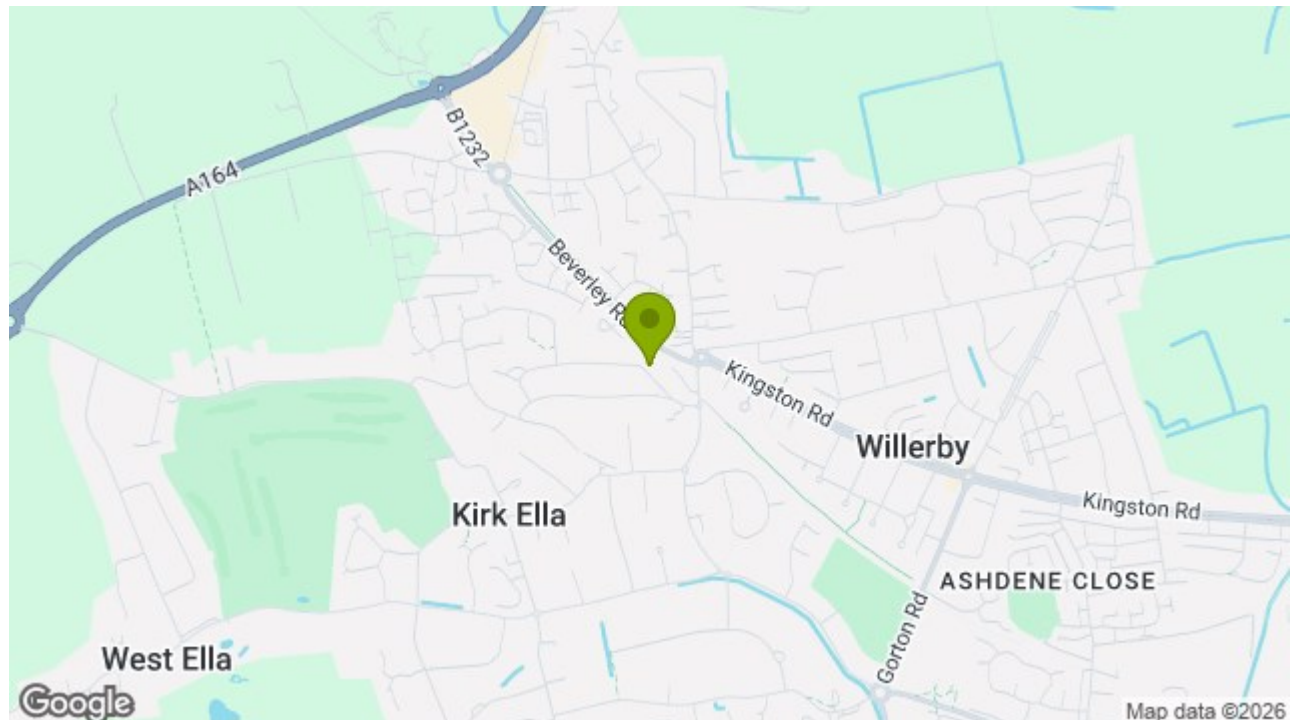
# Fairfield Avenue, Hull, HU10 7UG

## **KIRK ELLA**

The popular village of Kirk Ella lies approximately five miles to the West of Hull City Centre and is ideally located for all amenities. 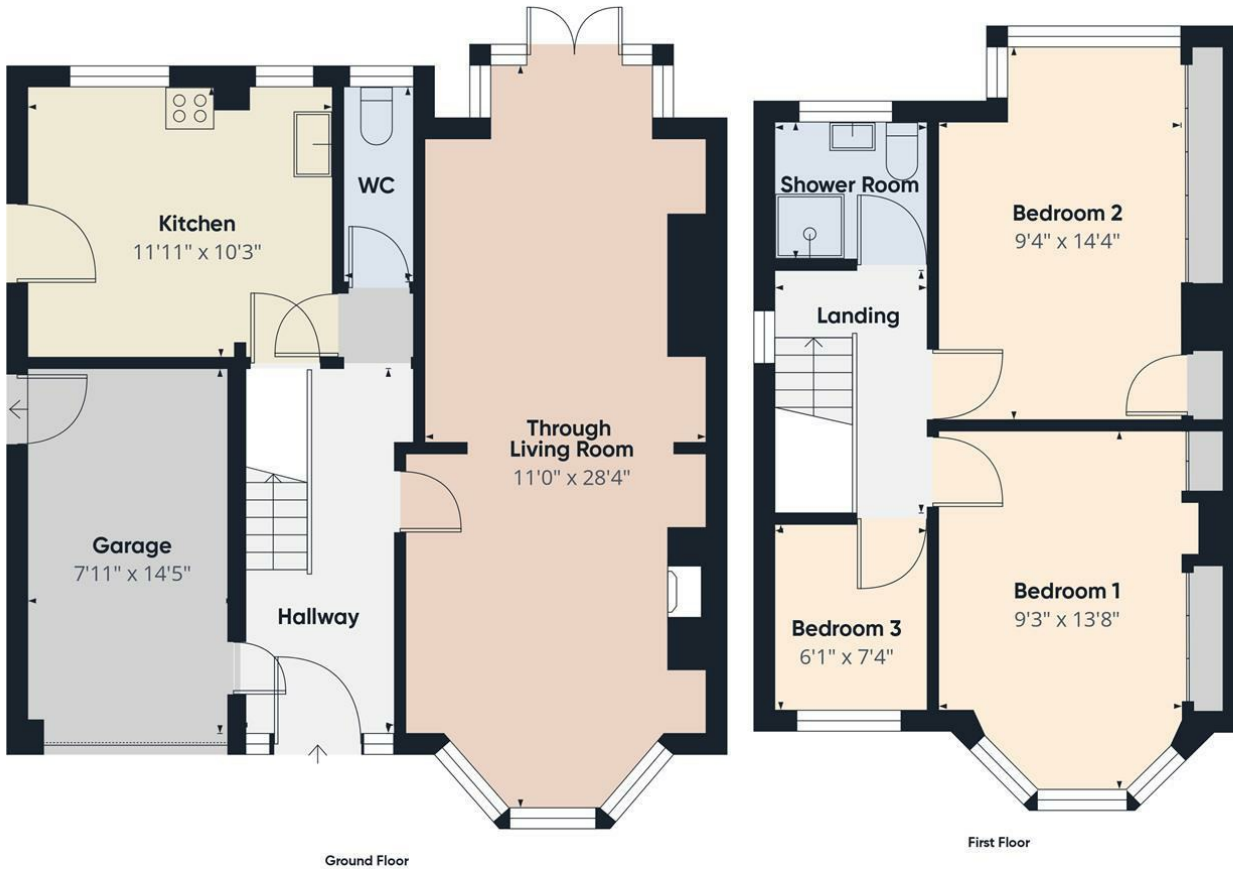
