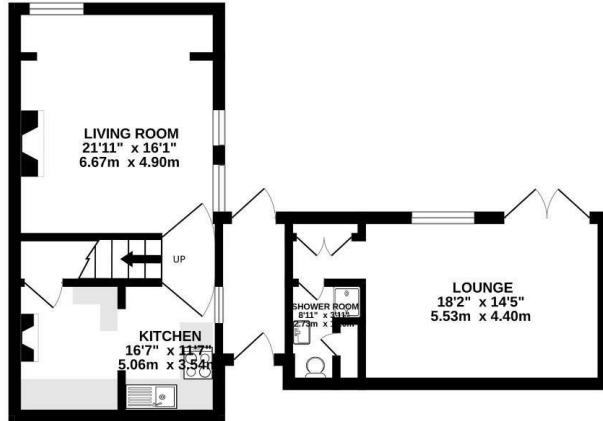

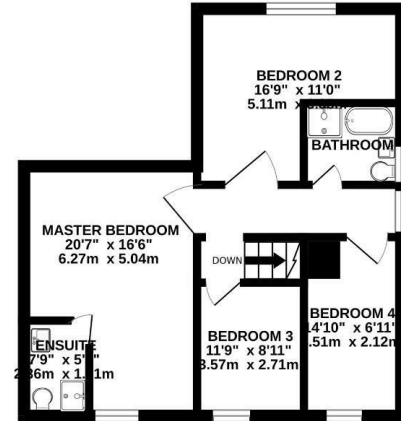

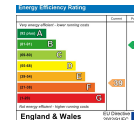

Holding Deposit (per tenancy)
