DIRECTIONS

From Shrewsbury town centre proceed along Smithfield Road taking the left turn into Chester Street. Proceed under the railway bridge staying in the left hand lane and turn left onto Castle Foregate. Continue along Castle Foregate and St. Michael's Street, proceed over the mini roundabout. Continue past the row of shops on the right hand side and just past next set of traffic lights Comet Drive is the right hand turn. Proceed along Comet Drive and No. 44 will be found on the right hand side clearly identified by a Halls 'For Sale' Board.

SITUATION

The property is conveniently situated in this established residential area close to a number of amenities including shops and schools. The town centre is easily accessible and commuters will be pleased to note that there is easy access to the main Shrewsbury bypass with links to the M54 motorway and on to Telford.

DESCRIPTION

This semi-detached house requires extensive modernisation and refurbishment, allowing prospective purchasers the opportunity to incorporate their own designs and tastes to all areas of the house. Families will be pleased to note the provision of 2 separate reception rooms, whilst there is also potential to extend the property, subject to any necessary planning consents required. The kitchen includes fitted wall and floor units and integrated appliances. On the first floor there are 3 bedrooms which are served by the family bathroom.

OUTSIDE

The property is approached over a tarmacadam driveway, providing parking and pedestrian access to the front of the property.

The majority of the gardens lie to the rear of the property and are again in need of attention and improvement.
