## Situation

The land is located in the village of Alderminster along the Shipston Road, approximately 5 miles northwest of Shipston-On-Stour and 4 miles southeast of Stratford-Upon-Avon.

The land is located within a Nitrate Vulnerable Zone for surface water, and within Flood Zones 2 & 3.

## Soil Type

The land is mostly classified as Grade 3, with some Grade 4 land adjacent to the river (Provisional Agricultural Land Classification). The soils are mostly lime-rich, loamy and clayey soils with impeded drainage (Soilscape 9).

## Sporting, Timber, and Mineral Rights

The sporting, timber, and mineral rights, where owned, are included in the freehold sale.

## Tenure and Possession

The land is sold Freehold with Vacant Possession available upon completion. Title Number WK542463.

## Rural Payments Agency

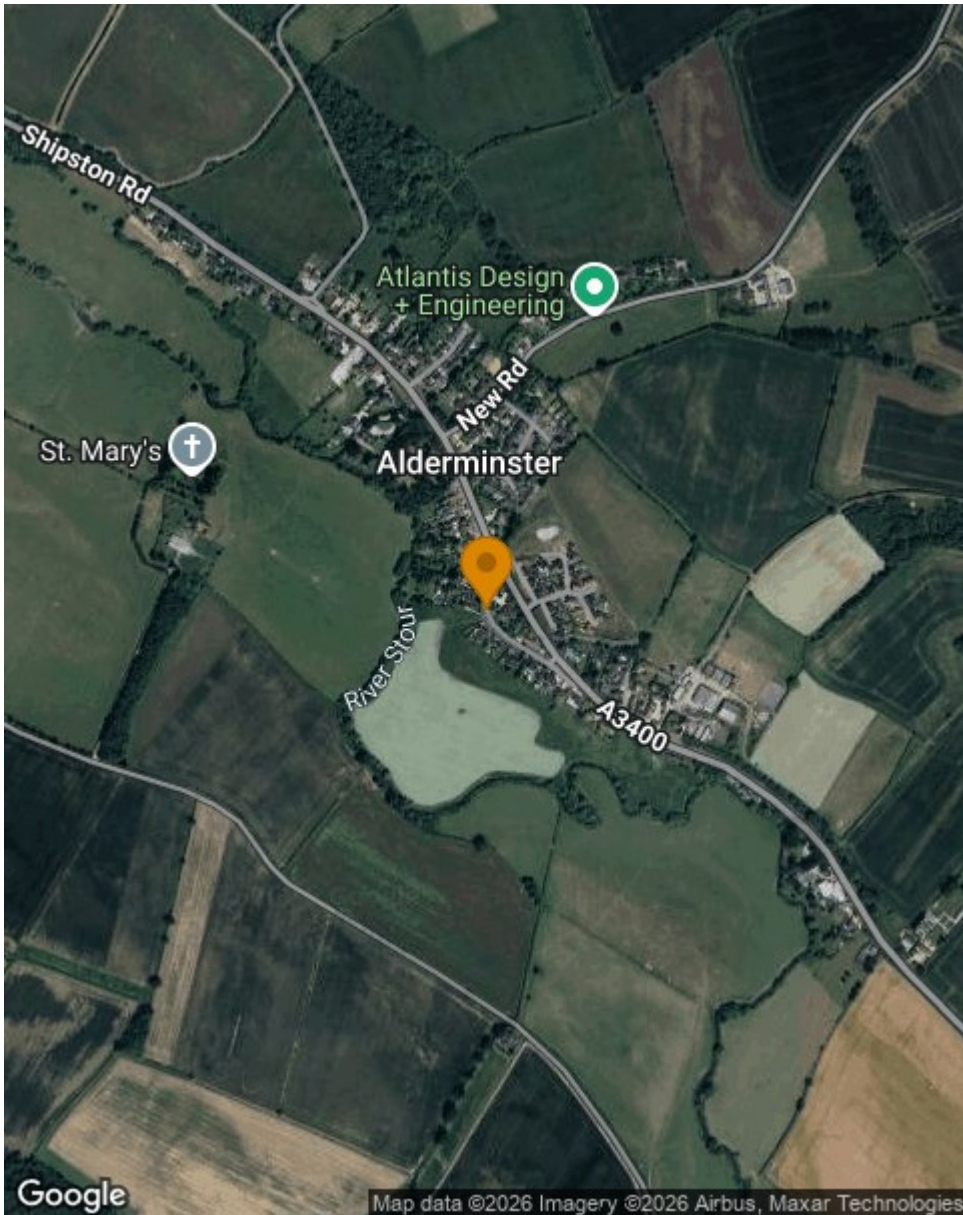

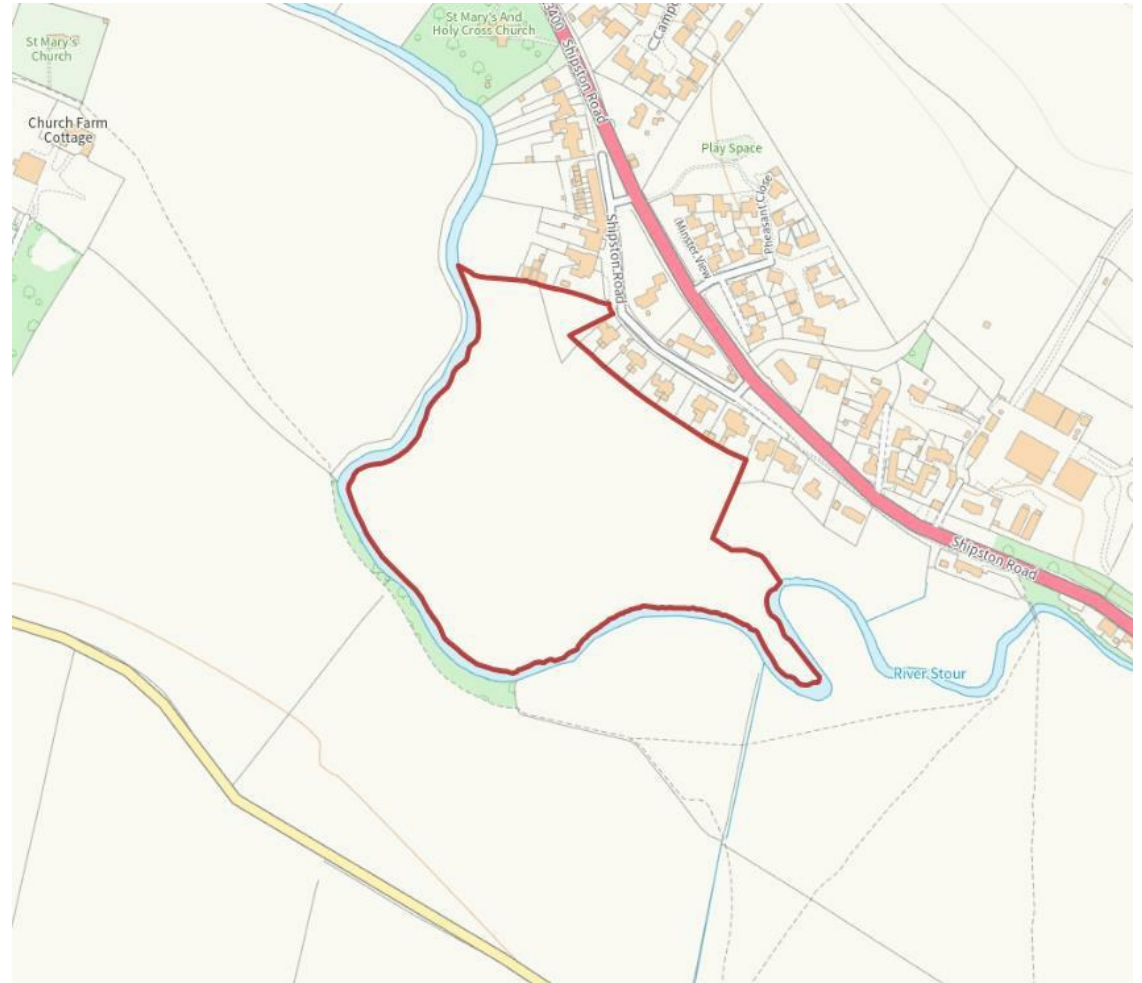
### **Restrictions**
