17' 06" x 10' 11" max (5.33m x 3.33m) uPVC double glazed bay windows and uPVC double glazed window to side aspect, tiled floor, inset lighting, integrated fridge/freezer, integrated dish washer, space for washing machine. Built in double oven, 5 ring gas hob and extractor over, 1 1/2 bowl sink unit with mixer tap

FIRST FLOOR LANDING

Access to insulated loft, airing cupboard. Doors to:

MASTER SUITE BEDROOM

11' 7" x 10' 7" (3.53m x 3.23m) uPVC double glazed sash window, radiator. Door to:

ENSUITE

Walk in double shower with sliding door and shower over, tiled splash backs, low level WC, pedestal basin, tiled floor, frosted uPVC double glazed sash window, heated towel rail, shaver point, extractor fan.

BEDROOM TWO

10' 00" x 8' 08" (3.05m x 2.64m) uPVC double glazed sash window, radiator.

BEDROOM THREE

11' 02" max x 8' 07" max (3.4m x 2.62m) L shaped, radiator, uPVC double glazed sash window.

BEDROOM FOUR

8' 04" x 6' 08" (2.54m x 2.03m) uPVC double glazed sash window, radiator.

BATHROOM

Panelled bath with mixer tap and hand shower attachment, low level WC, pedestal basin, heated towel rail, tiled floor.

OUTSIDE

FRONT

Shrubs to front and side, pathway to front door.

REAR GARDEN

Laid to lawn, shed, gated access, paved patio, outside tap



Up and over door.


THREE ALLOCATED PARKING SPACES


