This spacious apartment is entered from the first floor with stairs leading up to a south facing terrace on the hall landing. The second floor consists of a light filled reception, kitchen and office. The flat has been interior designed to a wonderful standard, with neutral colours making the living space calm and relaxing. Upstairs on the third floor are two double bedrooms with great storage and two bathrooms, one of which (the master) is en-suite. 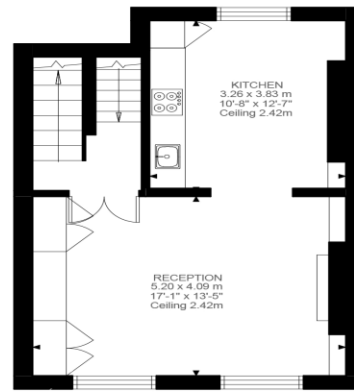
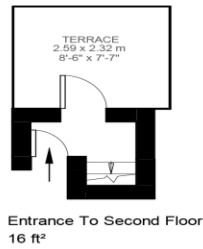

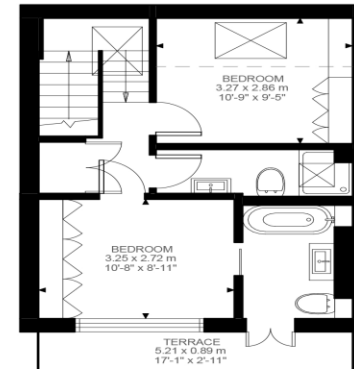
