Via a wooden door with security spy hole, leading into lounge/diner.

BEDROOM

Double glazed window to front overlooking communal gardens, coved ceiling, telephone point, TV aerial point, airing cupboard, single fronted storage cupboard, electric wall heater, door leading into wet room.

Ceiling with recessed LED spots light, modern white suite comprising; W.C. wash hand basin and shower with grab rails, shaver point, chrome heated towel rail.

Road Map



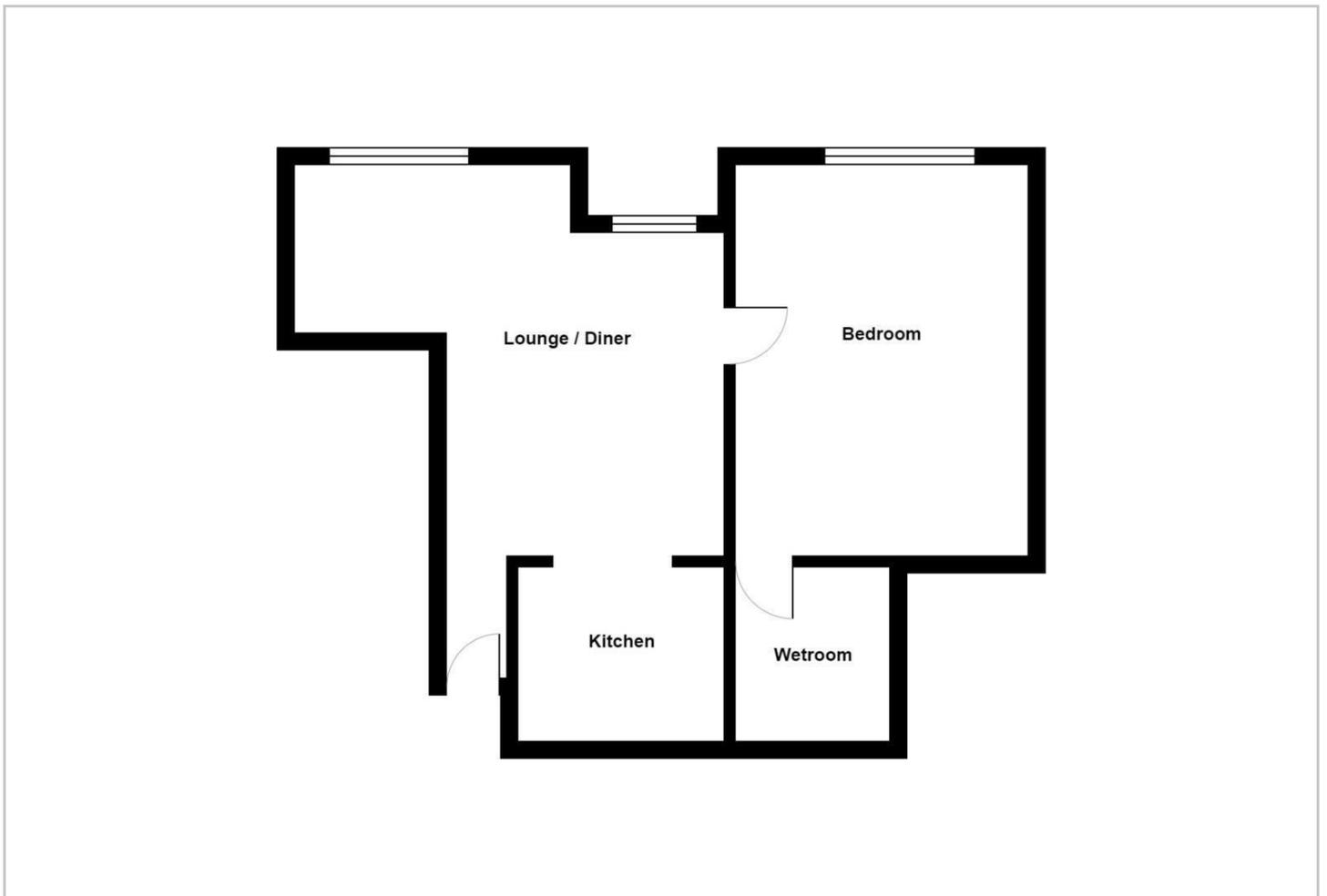
Hybrid Map



Terrain Map



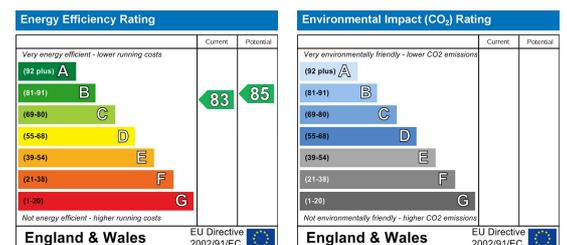
Floor Plan
