



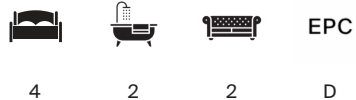

The ground floor features two spacious reception rooms, each centred around a working fireplace. At the heart of the home is a stylish Neptune family kitchen with integrated appliances and a practical pantry, complemented by a cellar providing excellent additional storage. Further ground-floor accommodation includes a guest WC and laundry room. Upstairs, the house offers four well-proportioned double bedrooms and two bathrooms, including a principal bedroom with an en suite.
