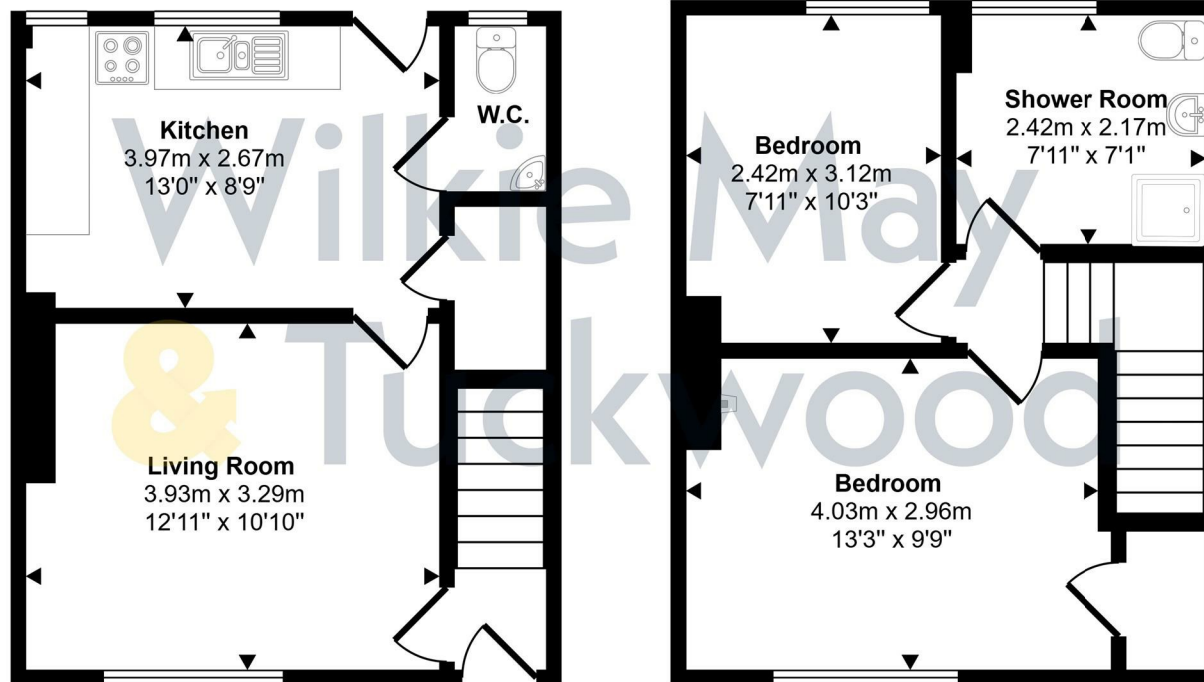

The accommodation in brief comprises; uPVC glazed door into Entrance Hall; door into Living Room; with aspect to front, door into Kitchen/Breakfast Room; with aspect to the rear, a range of cream shaker style cupboards and drawers under a wood effect rolled edge worktop with inset stainless steel sink and drainer, space for electric cooker, space for a tall fridge freezer, space and plumbing for a washing machine, large under stairs storage cupboard, door into the Downstairs WC; with low-level WC and corner wash basin with tiled splashback.

Stairs to the 1st floor landing; with hatch to roof space. Bedroom One; with aspect to front and original feature cast iron Victorian fireplace, built-in cupboard over the stairs. Bedroom Two; with aspect to rear. Shower Room with aspect to rear, shower cubicle with multi panelled surround, and an Electric Mira shower over, low-level WC, wash basin inset into a vanity unit, wall mounted Vaillant Combi boiler for central heating and hot water.

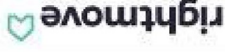
