Lordship Lane is enviably-located for the independent shops, bars, restaurants and coffee shops further down The Lane and on North Cross Road. There are a choice of gorgeous parks and green spaces nearby - including Dulwich Park, Peckham Rye and Goose Green. There are strong transport links into The City and West End from East Dulwich station (0.8 miles), North Dulwich station (0.8 miles) and Forest Hill station (1.4 miles) as well as a host of bus/cycle routes through the neighbouring Dulwich Village, Peckham Rye and Denmark Hill.

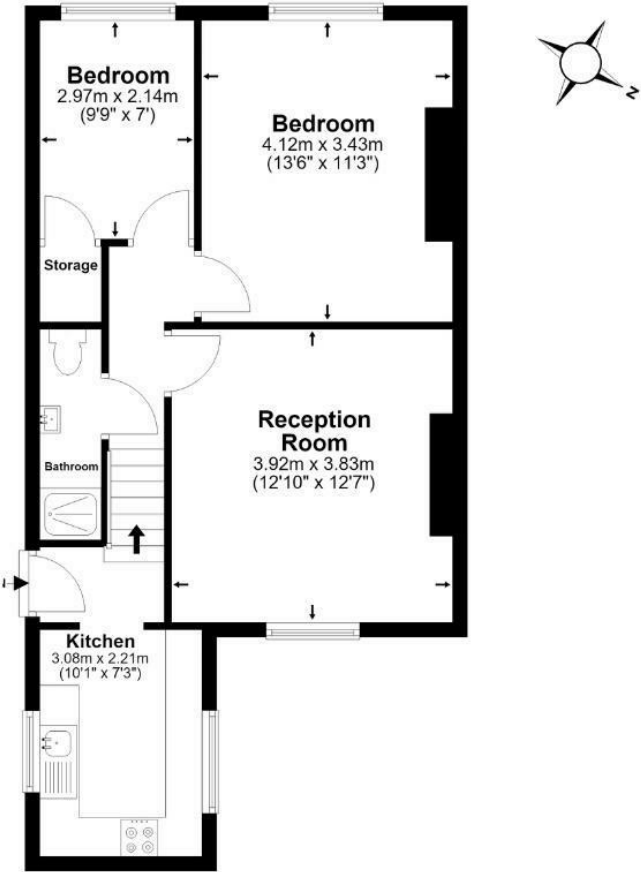


Floorplan

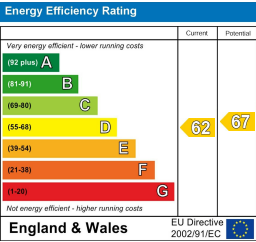
