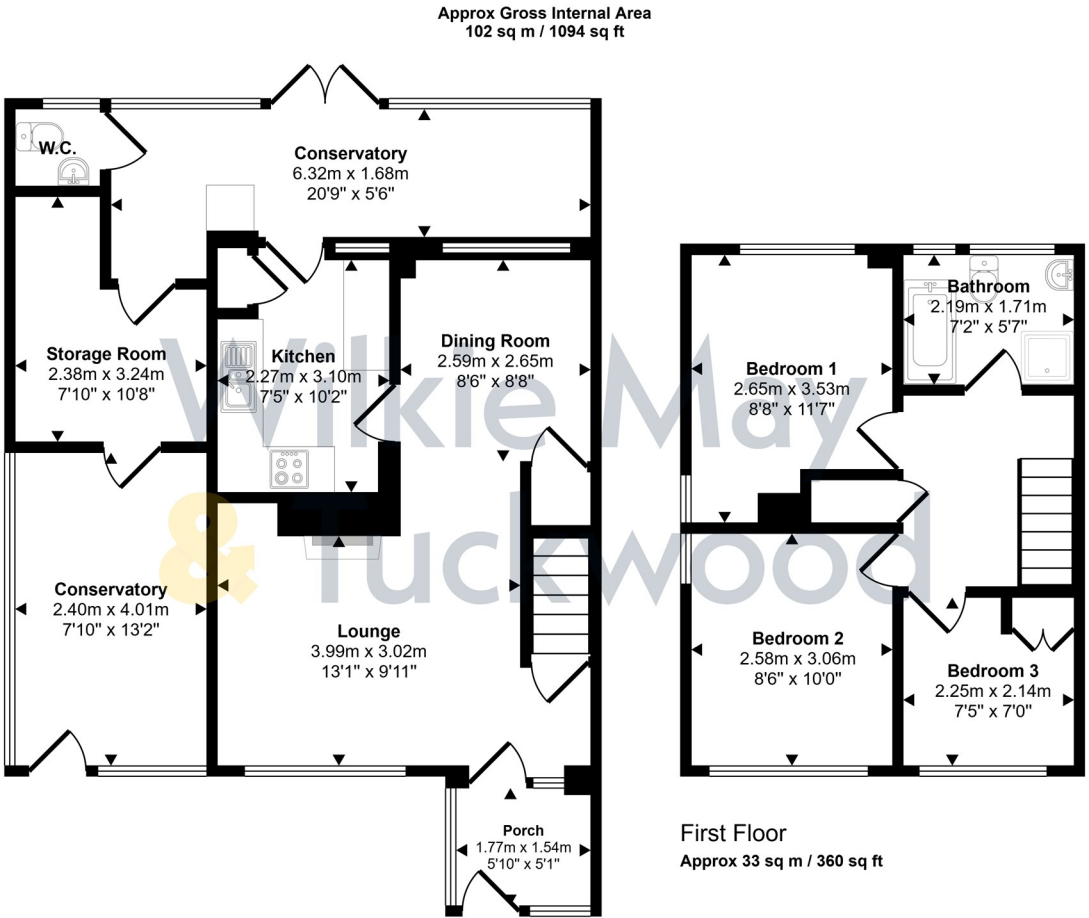

Occupying a corner plot – A three bedroom end of terrace house, with solar panels, air source heating and No Onward Chain.

The accommodation in brief comprises; uPVC double glazed doors into the Garden Room; tiled floor, aspect to rear overlooking the gardens, basic range of kitchen units with space and plumbing for a washing machine and space and plumbing for a dishwasher, door into Downstairs WC; tiled floor, low level WC, wash basin, door into Workshop, door into Greenhouse. Half glazed door from the Garden Room into the Kitchen; wood effect laminate flooring, beech effect cupboards and drawers and a marble effect rolled edge worktop with inset stainless steel sink and drainer, four ring ceramic hob, electric oven under, space for under counter fridge. L Shaped Living Room/Dining Room; under stairs storage cupboard, wood effect laminate floor, aspect to front, wood burner inset into chimney breast with tiled surround and hearth, half glazed door into the Entrance Porch; tiled floor.

Stairs to first floor landing; hatch to roof space, airing cupboard housing copper cylinder with immersion switch. Bedroom 1; double aspect and views. Bedroom 2; double aspect. Bedroom 3; aspect to front. Family Bathroom; with a white four piece suite comprising a panelled bath, separate shower cubicle with electric Triton shower over, low level WC, pedestal wash basin.

OUTSIDE: The property has off road parking via a car port and with some adjustment, further off-road parking could be created within the top garden area. There is also a single garage access via West Street.

The gardens comprise 3 parts in total. The front garden, rear garden and top garden, playing host to a number of established fruit trees, to include apples, pears, and plums.
