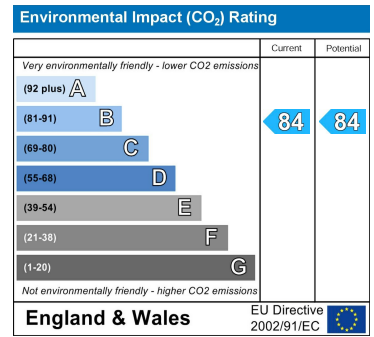
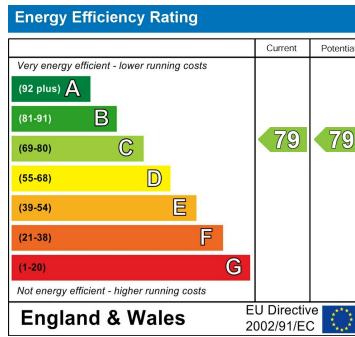
KITCHEN
