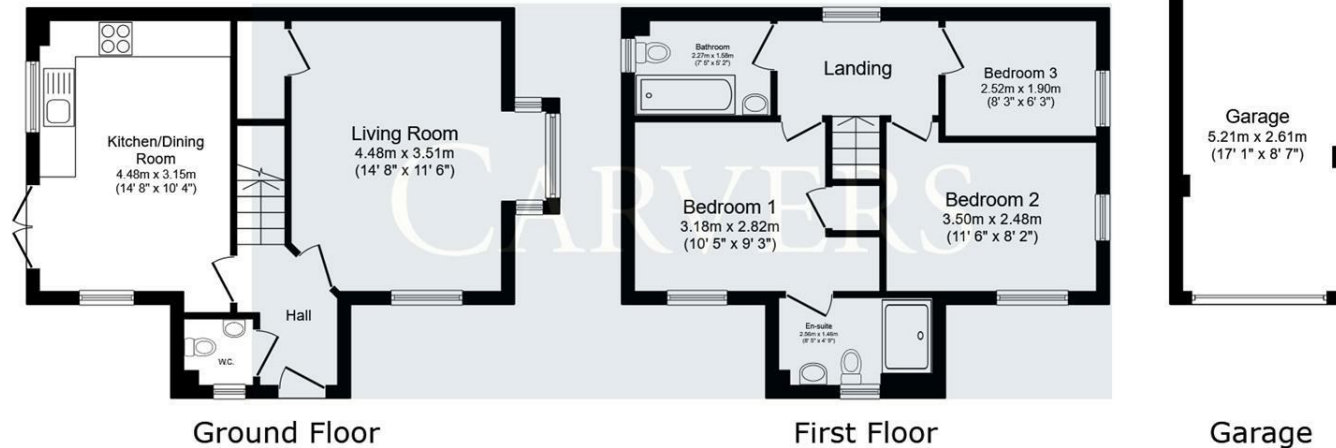
## Buyer(s) Identification Checks
