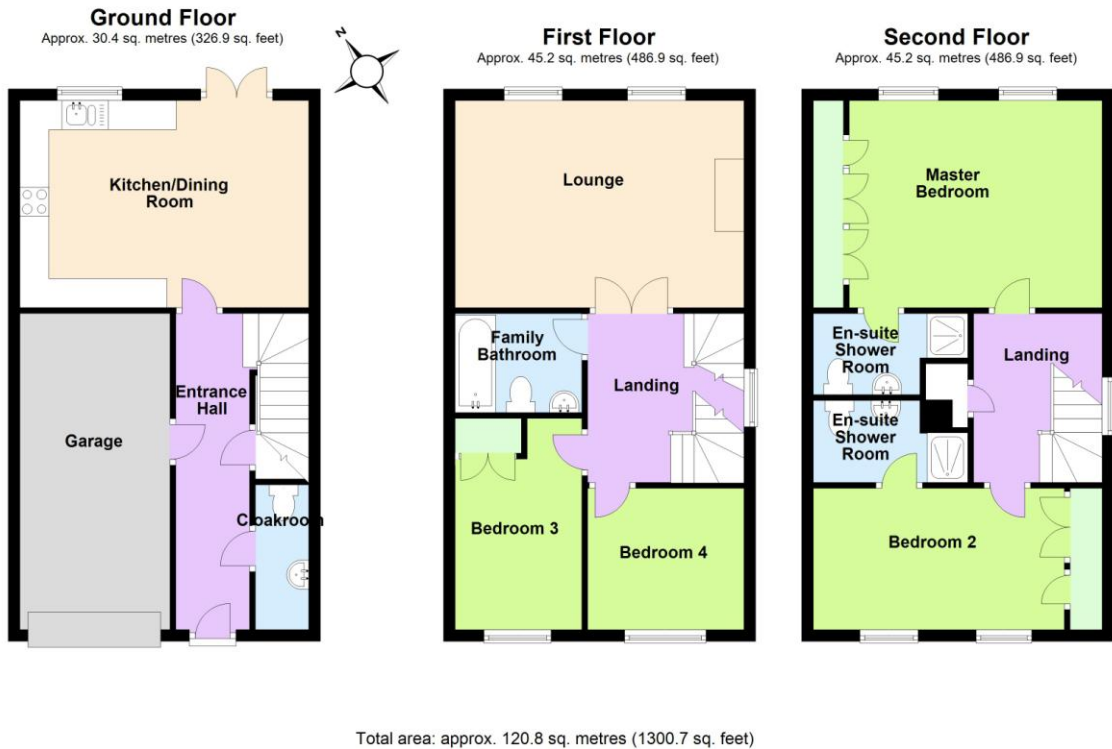

The accommodation briefly comprises entrance hall, cloakroom, kitchen/breakfast room, first floor landing, bathroom, two bedrooms, second floor landing, two further bedrooms both with en suite shower rooms, rear garden, garage and driveway.

Entrance Hall

Radiator, stairs rising to first floor landing, built-in cupboard, doors to:

Cloakroom

Comprising low flush W.C., wall mounted wash hand basin, tiled splash backs, radiator, extractor.

Kitchen/Dining Room

16' 4" x 11' 6" (4.98m x 3.51m) (This measurement includes area occupied by kitchen units)

Comprising stainless steel one and a half bowl single drainer sink unit with cupboard under, a range of eye level and base units providing work surfaces, built-in stainless steel oven, gas hob, extractor hood, built-in slimline dishwasher, plumbing for washing machine, built-in fridge, window and door to rear aspect, tiled splash backs, radiator.

Stairs rising to second floor landing, radiator, window to side aspect, doors to:

Window to front aspect, radiator, built-in double wardrobe.

Bedroom Four

8' 9" x 8' 1" (2.67m x 2.46m)

Window to front, radiator.

Airing cupboard housing wall mounted gas combination boiler serving domestic central heating and hot water systems, window to side aspect, doors to:

Two windows to rear aspect, a range of built-in wardrobes, door to:

Ensuite Shower Room

Comprising low flush W.C. pedestal wash hand basin, shower cubicle, tiled splash backs, radiator.

14' 4" x 8' 1" (4.37m x 2.46m)

Two windows to front aspect, two radiators, a range of built-in wardrobes, door to:

Ensuite Shower Room

Comprising low flush W.C., pedestal wash hand basin, shower cubicle, radiator, tiled splash backs.

Outside

Front - Block paved driveway providing side by side parking for two cars, leading to:

Garage - Remote controlled up and over door, power and light connected, personnel door to hallway.

Rear - Patio area, steps up to lawn with border stocked with a variety of shrubs and bushes, enclosed by wooden fencing with gated side pedestrian access.
