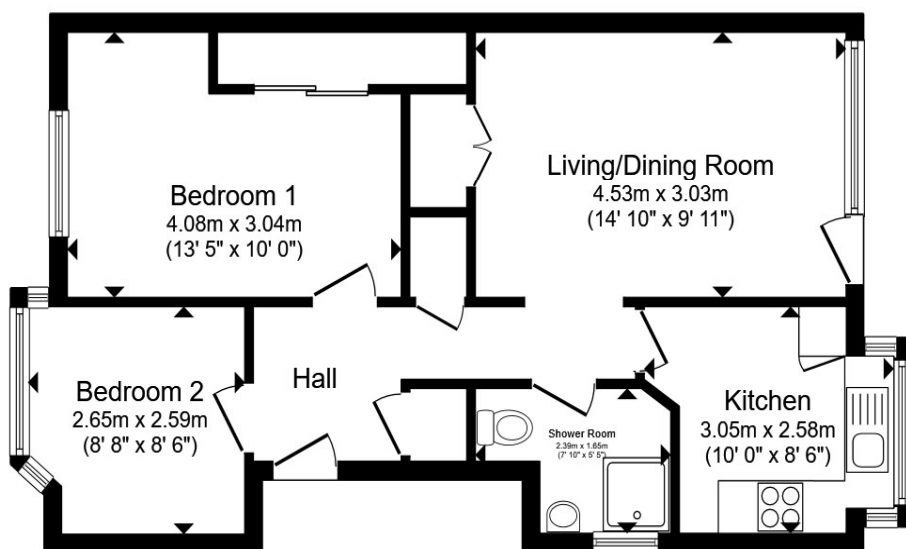

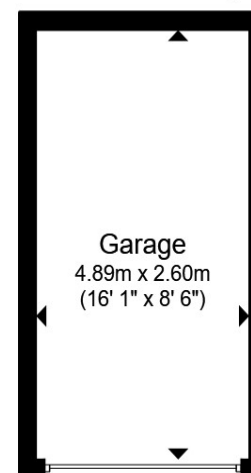




Floor Plan
