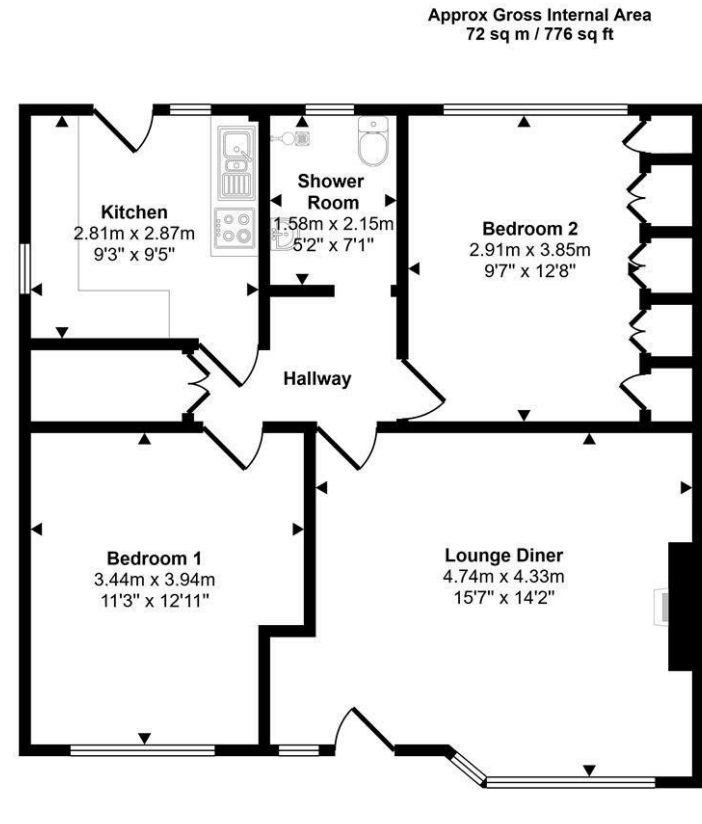

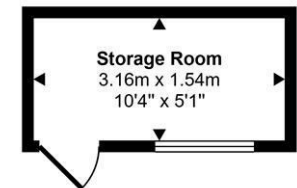

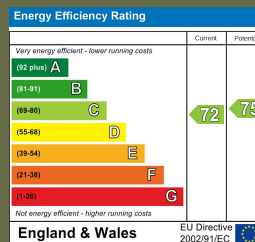


Ground Floor
