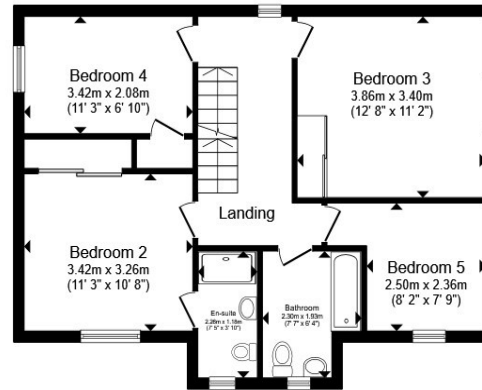

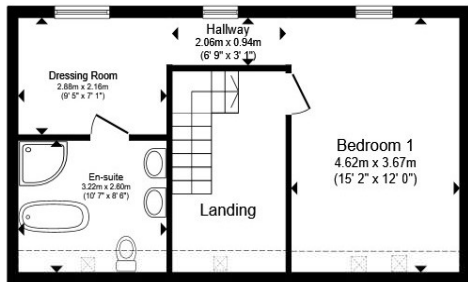




**Ground Floor**

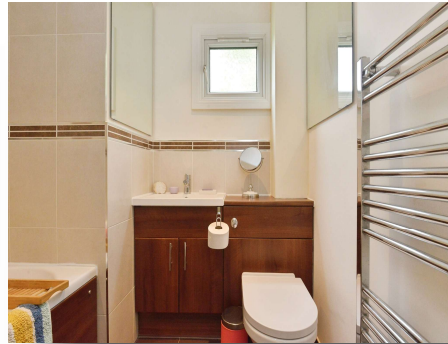
