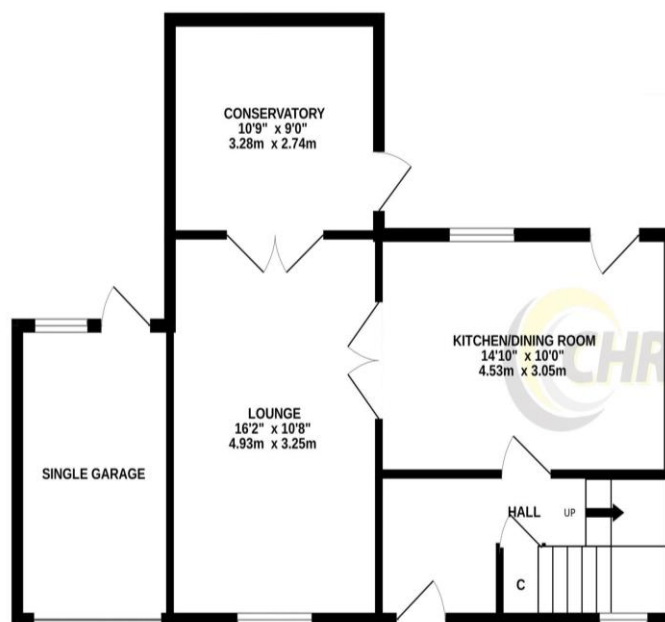

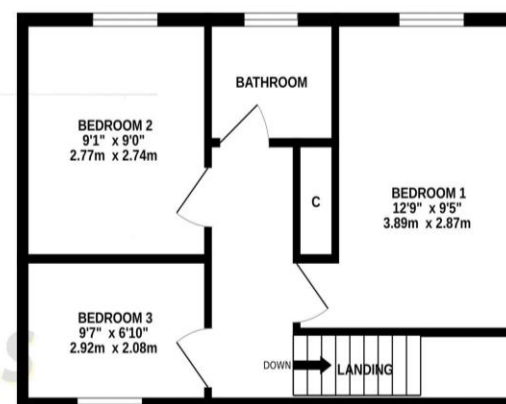




GROUND FLOOR
