THE PROPERTY

There are three entrances into the building, one providing a lift to all floors and the other two with stairs to all floors. The first floor apartment comprises an entrance hallway, a kitchen/breakfast room comprising of a range of floor and wall mounted units with under pelmet lighting and worktops over, Belfast sink, integrated electric oven and hob with extractor fan above. Integrated microwave, dishwasher, washer/dryer, and fridge/freezer. The floor is tiled and offers space to include a breakfast table.

The dual aspect sitting/dining room is filled with natural light with views over Woodlands Crescent.

There are two double bedrooms, the principal bedroom is dual aspect and enjoys an en-suite shower room. Bedroom two has fitted wardrobes. There is also a well-appointed family bathroom and useful store room.

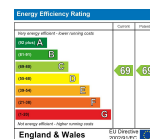
