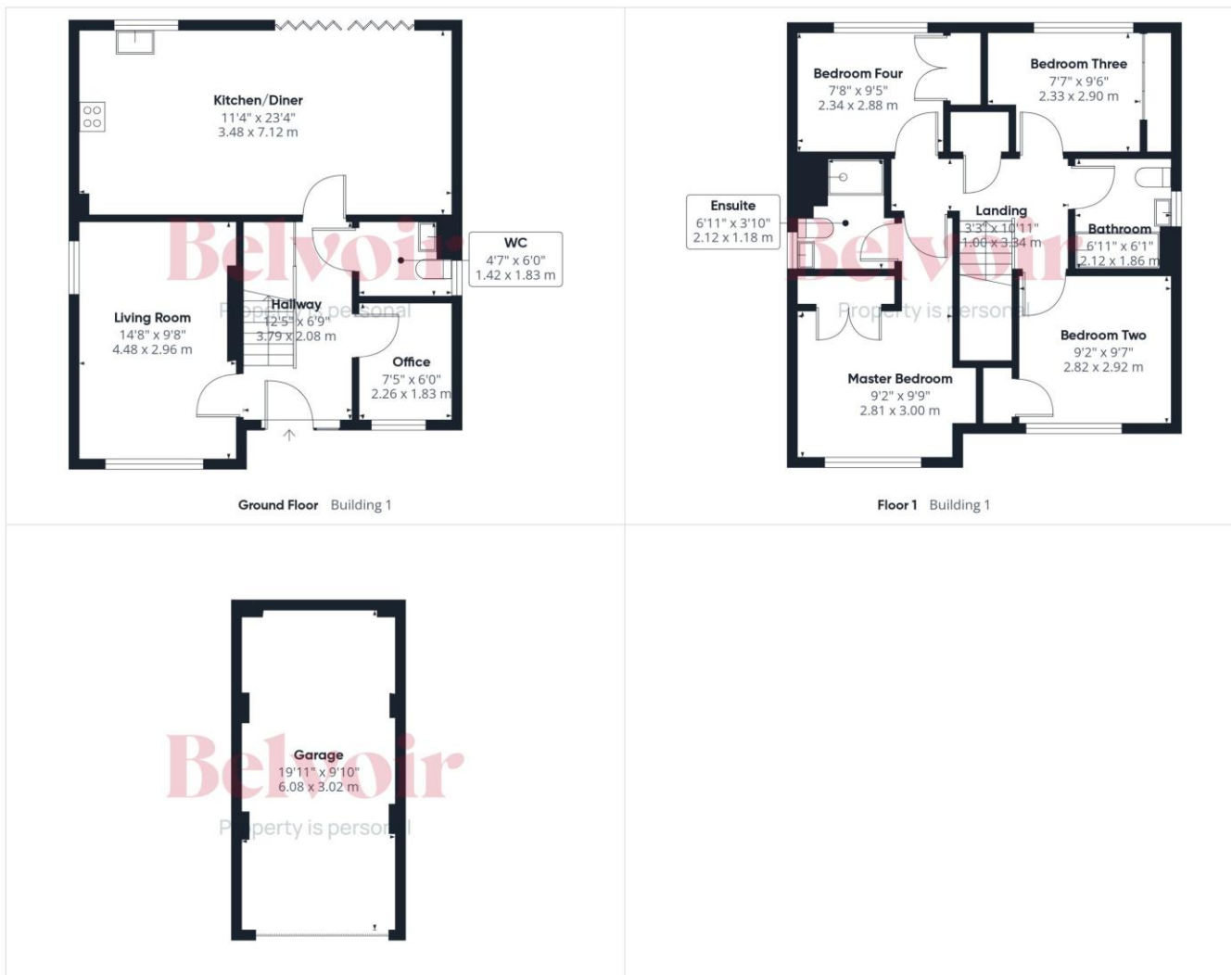
Description
