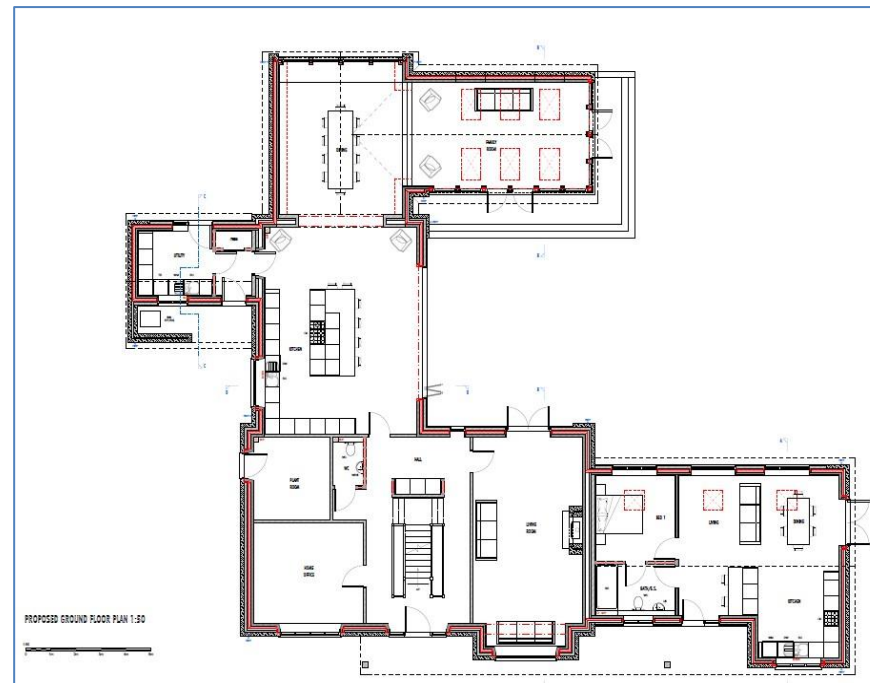
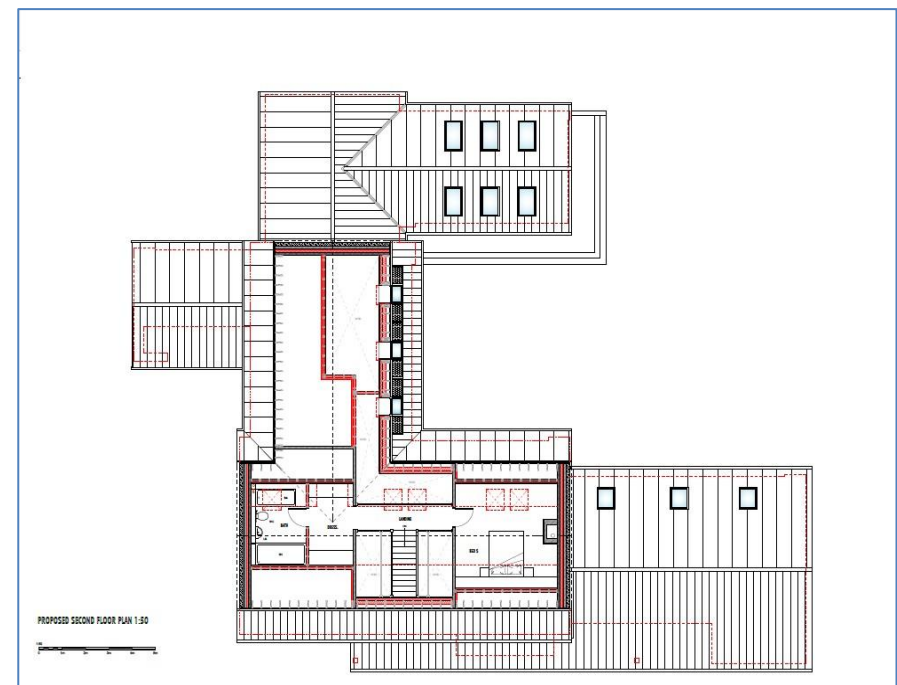
PROPOSED WEST (FRONT) ELEVATION
