The properties can be purchased either individually or bought jointly with Mary Haig.

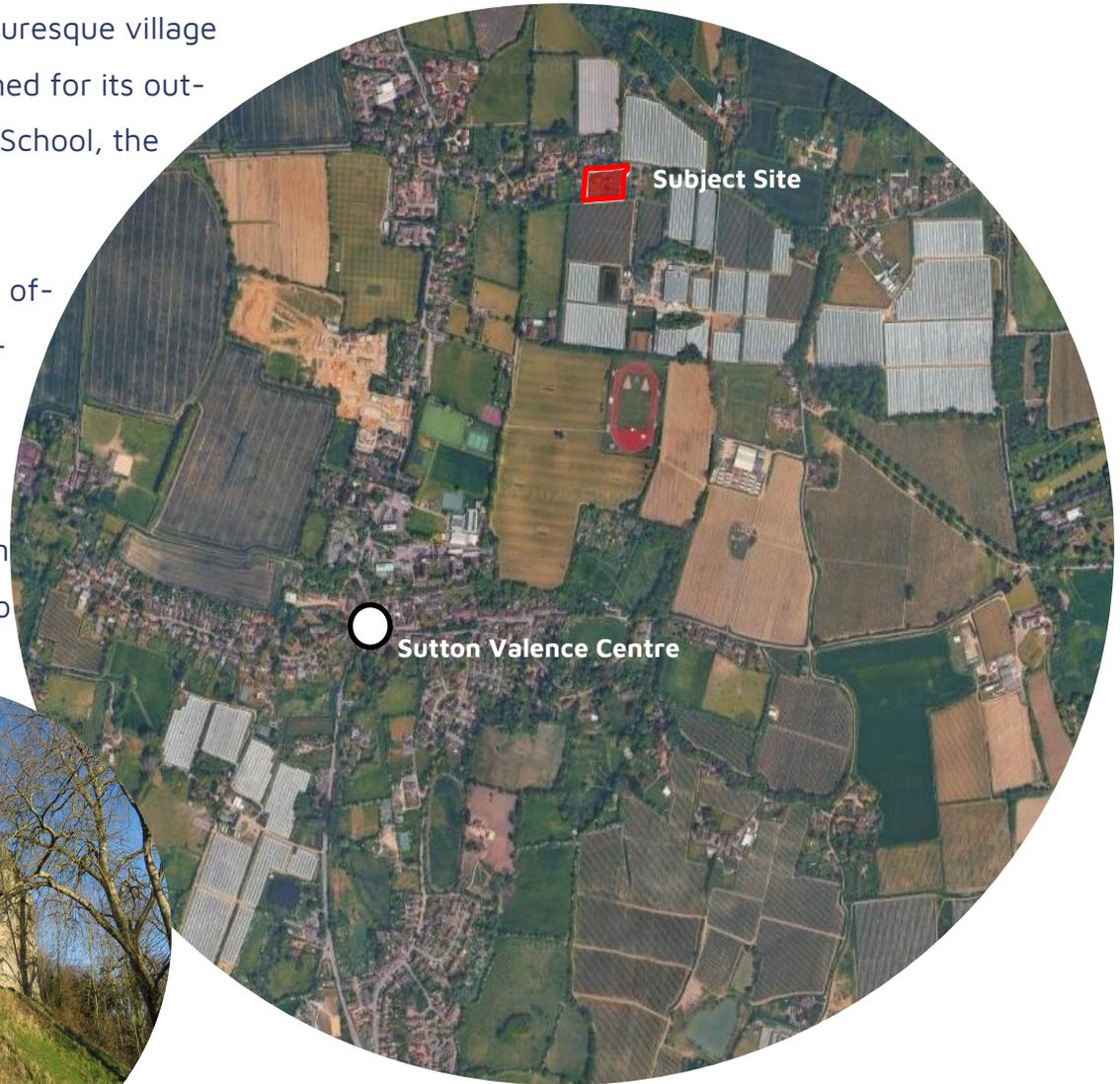


Location

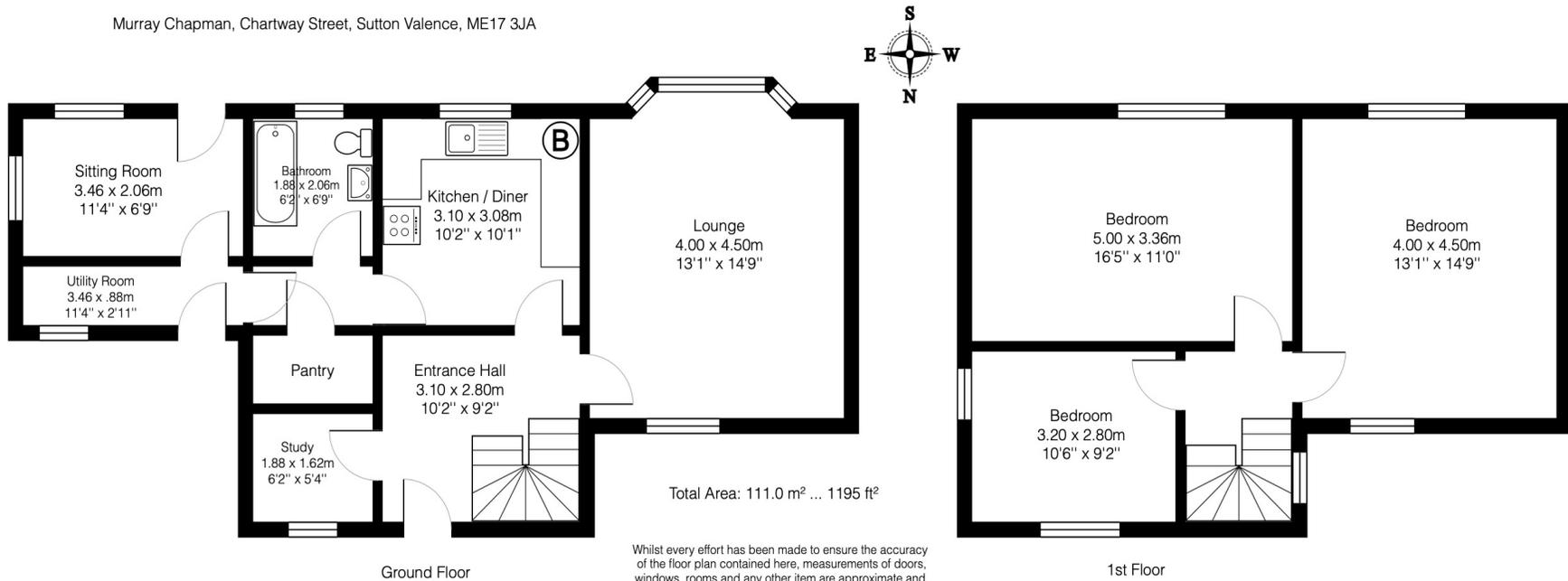

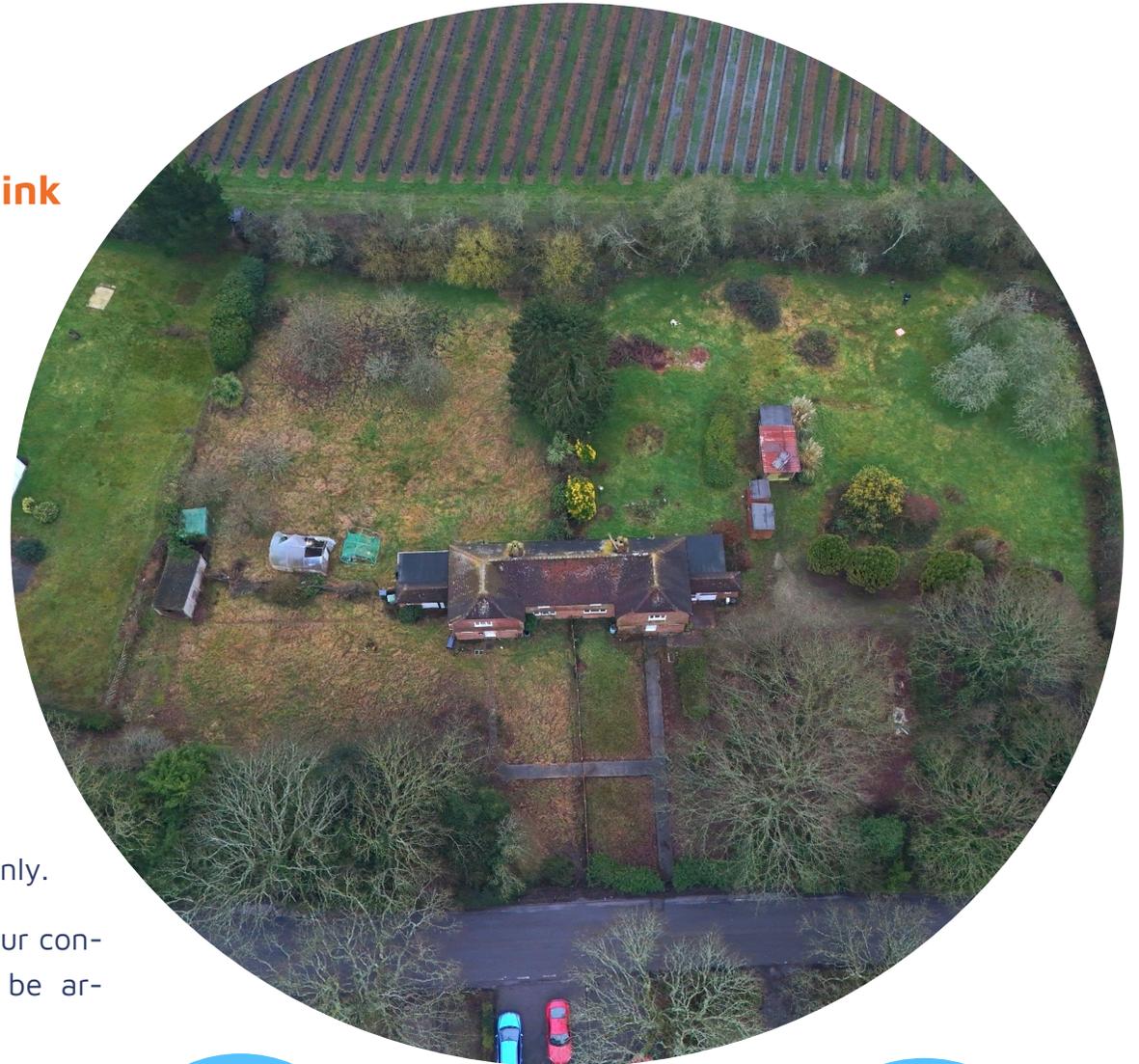
