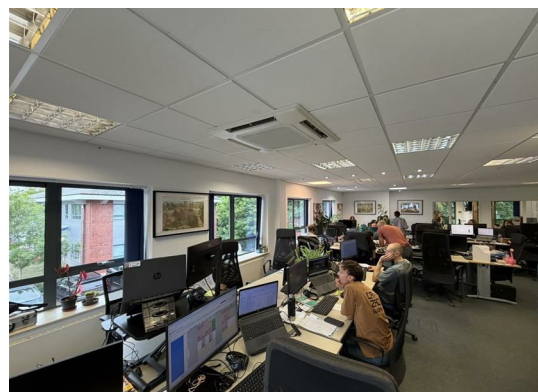
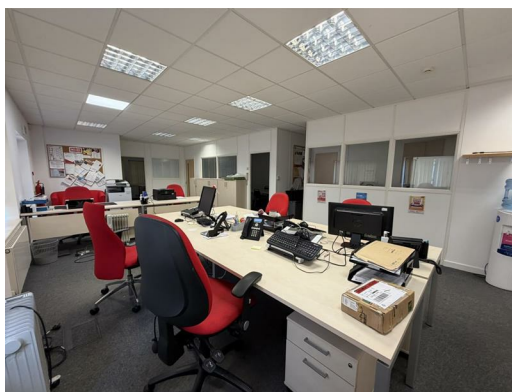

The offices are located in Eden Office Park in a semi rural location on the edge of Bristol in Ham Green, providing easy access to the M5.

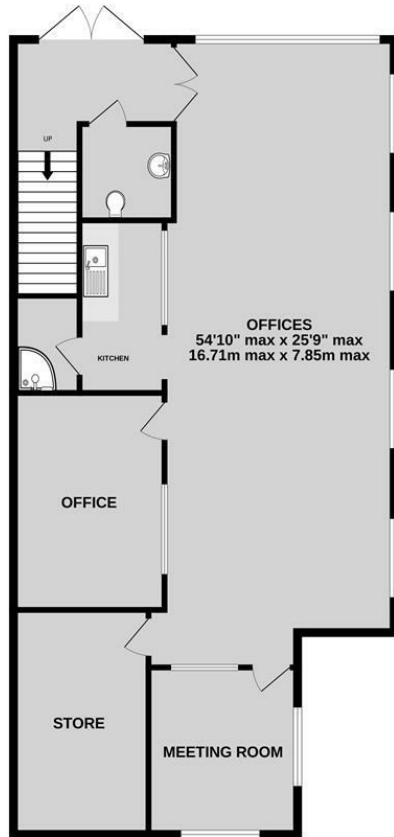

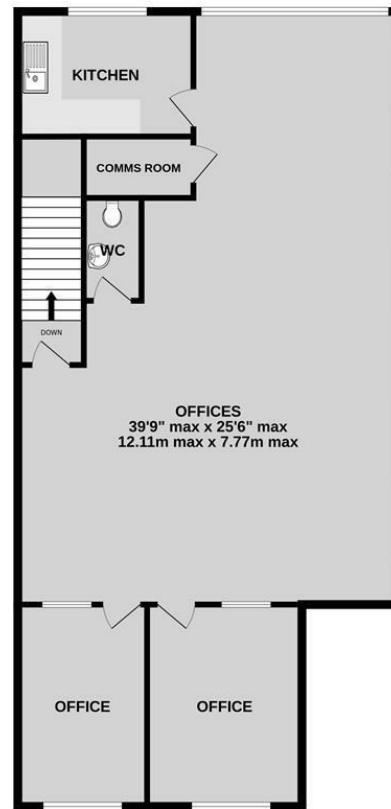
