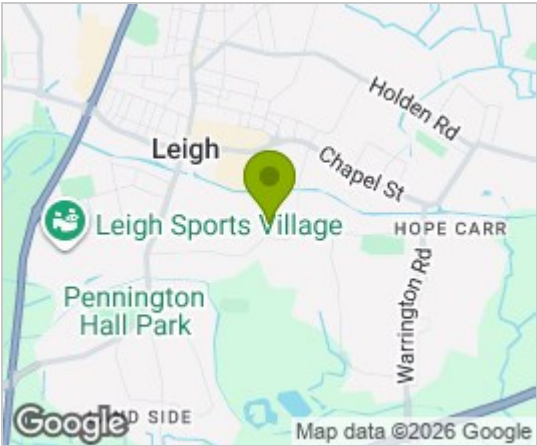

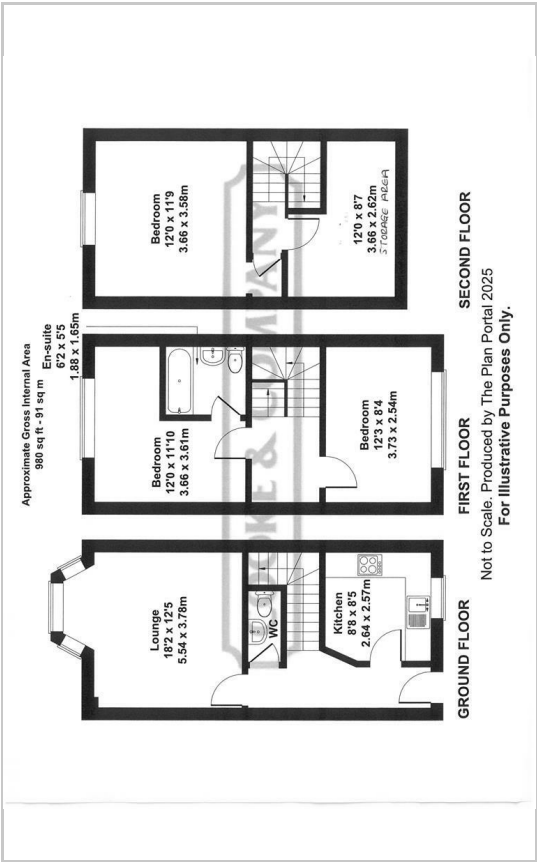

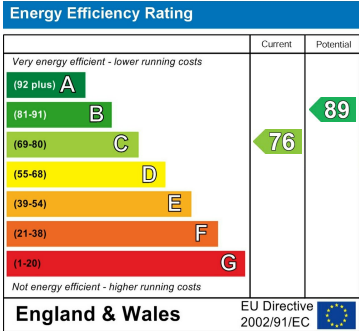
Area Map
